Temporarily amends 312 IAC 8-1-3(b) to allow firewood certified by another state's compliance agreement meeting minimum requirements set by the state entomologist to be brought into or possessed on a DNR property. Effective May 10, 2022. This document expires on May 9, 2023.

20220511-IR-312220158ERA 22-158

Temporarily amends 312 IAC 9 to govern noncommercial hunts at specified state parks. Under IC 14-22-6-13, the director finds white-tailed deer have caused, and will continue to cause, measurable damage to the ecological balance within these properties, and the ecological balance within these properties will not be maintained unless action is taken to control their populations. Effective May 30, 2022. This document expires January 1, 2023.

Temporarily establishes counties and the statewide quota for the trapping of river otters during the 2022-2023 river otter season. Effective November 15, 2022. This document expires on March 16, 2023.

Temporarily amends 312 IAC 9-3-2 governing wearing hunter orange in deer reduction zones and 312 IAC 9-3-4 governing the hunting of white-tailed deer by establishing deer reduction zones. Effective September 15, 2022. This document expires February 1, 2023.	<u>20220608-IR-312220204ERA</u>	22-204
Temporarily amends 312 IAC 9-3-4 to govern hunting white-tailed deer in a designated county under an extra deer license by identifying counties for herd reduction. Effective September 1, 2022. This document expire on February 1, 2023.	<u>20220629-IR-312220223ERA</u>	22-223

governing the special antlerless deer season. Effective October 1, 2022. This document expires on January 2, 2023.

Temporarily amends 312 IAC 9 to govern noncommercial hunts at Spring Mill State Park, Summit Lake State Park, Versailles State Park, and Whitewater Memorial State Park. Under IC 4-22-2-37.1, IC 14-22-2-6, IC 14-10-2-5, and IC 14-22-6-13 (applicable to state parks), the director of the Department of Natural Resources (DNR) adopts the emergency rule set forth in this document. This emergency rule is adopted with the awareness that the regulation of wild animals, as well as a responsibility for the welfare of flora and other fauna within Indiana state parks, is the responsibility of DNR. The director finds that the densities of the Canada goose populations at Spring Mill State Park, Summit Lake State Park, Versailles State Park, and Whitewater Memorial State Park have risen to levels that pose threats to the ecology of aquatic and terrestrial communities present, and the personal safety of park patrons. Current conditions that make this emergency rule necessary include eroded shorelines, increased sedimentation, and large amounts of goose waste in areas of high visitation and recreation. Effective November 4, 2022. This document expires at the close of the hunting period on February 12, 2023.

Temporarily modifies 312 IAC 9-8-2 governing the regulation of commercial fishing on the White and Wabash Rivers for commercial fishers harvesting invasive carp through the Indiana Invasive Carp Removal Program (IICRP), and modifies 312 IAC 9-8-6 governing the regulation of commercial fishing on the Ohio River for commercial fishers harvesting invasive carp through the Ohio River Asian Carp Removal Program operated in conjunction with the Commonwealth of Kentucky under 301 KAR 1:152. Asian Carp and Scaled Rough Fish Harvest Program. Effective January 18, 2023. This document expires on January 18, 2024.

Temporarily amends 312 IAC 10-2-28 to add to the lowest floor definition to define the lowest floor for coastal high hazard areas. This document expires on January 12, 2024.

Temporarily amends 312 IAC 5 to provides that an individual may not operate a boat at a speed greater than idle speed on Cedar Lake when operating the boat at a distance less than 201 feet from: (1) dredging equipment; or (2) the center line that extends along the narrowest portion of Cedar Lake. Provides that a person who travels at a speed greater than idle speed on Cedar Lake when operating the boat at a distance less than 201 feet under specified circumstances commits a Class C infraction. Effective June 15, 2023. This document expires October 1, 2023.

Temporarily amends 312 IAC 4-4-6 to remove the provision permitting, at the will of the director of the division of law enforcement (division director) and subject to the approval of the director, a conservation officer who receives a spot appointment to be returned to the conservation officer's permanent grade before the spot appointment. Temporarily removes the definition of "spot appointment". Temporarily amends 312 IAC 4-5-2 to remove the requirement that a person who applies to become a conservation officer achieve an associate's degree, at least two years toward a bachelor's degree, or at least four years of full-time active duty military service with honorable discharge. Temporarily adds the requirement that a person who applies to become a conservation officer achieve a high school diploma or a general education diploma (GED). Temporarily amends 312 IAC 4-5-3 to require the division director to select a person to become a conservation officer based on indicators that the person will excel in a career in conservation law enforcement, including the person's life experiences and interest in and commitment to natural resources. Statutory authority: IC 4-22-2-37.1; IC 14-9-8-3; IC 14-10-2-4. Effective June 15, 2023. This document expires June 15, 2024.
