| Monday, October 24, 2005 | -Senators may begin filing bills for the 2006 Session. No limit on number of bills filed. (Senate Rule 42) |
| Tuesday, November 22, 2005 | -Organization Day for the 2006 Session (IC 2-2.1-1-2(a)) - Representatives may begin filing bills (House Rule 104) |
| Tuesday, January 3, 2006 | -Senators may file only two bills per business day beginning today. (Senate Rule 45(a)) |
| Monday, January 9, 2006 | -Session must reconvene (IC 2-2.1-1-2(d)) |
| Monday, January 9, 2006 | -Deadline for filing Senate bills (Senate Rule 45(a)) no later than 4:00 p.m. |
| Fourth Meeting Day in January
(January 10, 2006) | -Deadline for filing House bills (House Rule 108.1, no later than 2:00 p.m. modified by House Rule 2.1) |
| Fifth Meeting Day in January | -Filing of House vehicle bills (House Rule 107) |
| Monday, January 16, 2006 | -Last day Senate bills may be assigned to Senate committees. (Senate Rule 46(a)) |
| Ten (10) calendar days after filing
(Last day January 20, 2006) | -Last day House bills may be assigned to committees unless committees have not been appointed, in which case bills shall be referred within ten (10) calendar days after the appointment of committees. (House Rule 113) |
| Thursday, February 2, 2006 | -Last day for 3rd reading of Senate bills in Senate (Senate Rule 76(a), as modified by Senate Rule 85(b)) |
| Thursday, February 2, 2006 | -Last day for Senate to receive House bills (Senate Rule 76(c), as modified by Senate Rule 85(b)) |
| Thursday, February 2, 2006 | -Last day for 3rd reading of House bills in House (House Rule 147.1 , as modified by House Rule 2.1) |
| Thursday, March 2, 2006 | -Last day for 3rd reading of Senate bills in House (House Rule 148.1) |

- Thursday, March 2, 2006 -Last day for 3rd reading of House bills in the Senate (Senate Rule 76(b))
- Thursday, March 2, 2006 -Last day for House adoption of conference committee reports without Rules Committee approval (House Rule 162.1)
- Thursday, March 2, 2006 -Last day for Senate adoption of conference committee reports without Rules Committee approval (Senate Rule 83(i), (k))
- Tuesday, March 14, 2006 -Last day for adjournment of both houses (IC 2-2.1-1-2(e)).
