- (1) Citizen complaints concerning agency rules or practices.
- (2) Violations of the time frames within which agencies must promulgate and adopt rules.
- (3) Proposed agency rules that may have an economic fiscal impact of \$500,000 or more.

AROC may make recommendations to an agency that a rule be modified, repealed, or adopted. The Committee may also introduce legislation to make the statutory refinements necessary to correct an agency practice or regulation that represents a misapplication of Indiana law.

Census Data Advisory Committee
IC 2-5-19 (Permanent)

The Census Data Advisory Committee is required by statute to do the following:

- (1) Advise and assist the Bureau of the Census in the preparation and organization of decennial census data for use by the General Assembly in reapportionment.
- (2) Work with the Bureau of the Census in defining the boundaries of census blocks in Indiana.
- (3) Coordinate efforts to obtain an accurate population count in each decennial census.
- (4) Work with other state and federal agencies to assist in the local review program conducted in Indiana.
- (5) Work with the Code Revision Commission to prepare legislation in the regular session of the General Assembly that meets during the year of the effective date of the decennial census to propose amendments to Indiana law to reflect the population information obtained as a result of the decennial census.
- (6) Study costs and other relevant aspects of acquisition by the state of a geographic information system.
- (7) Make recommendations to the General Assembly concerning changes or amendments to election law including legislation from the implementation and administration of the Help America Vote Act of 2002 (42 U.S.C. 15301 through 15545).
- (8) Receive recommendations under IC 3-6-4.5-21.

The committee was assigned the following additional topics:

- (1) Study the standards for determining residency for purposes of voting, candidacy, and holding office in Indiana (IC 3-5-5). (HEA 1311)
- (2) Study allegations of voter suppression of African-Americans, Latinos, other ethnic minorities, and the elderly. (HEA 1311)
- (3) Study allegations of election fraud occurring in the:
 - (A) absentee voting process;
 - (B) candidate filing process;
 - (C) voter registration process; and
 - (D) voting process. (HEA 1311)

- (8) Study issues related to redistricting conducted by local units of government. (HEA 1311)
- (9) Study electioneering at the polls, vote centers, the office of the circuit court clerk, and satellite offices. (SEA 250)
- (10) Make any recommendations for legislation as the committee considers appropriate. (SEA 250)
- (11) Study methods for enabling an emergency first responder responding to an emergency declaration to receive an absentee ballot or absentee ballot application by electronic mail or fax. (SEA 518)
- (12) Study the impact of sending to a voter written communications containing false vote history information regarding that voter. (SEA 518)

Central Indiana Transit Study Committee
P.L. 212-2013 (HEA 1011) (July 1, 2014)

The Central Indiana Transit Study Committee shall:

- (1) Identify diverse potential funding sources for bus and bus rapid transit.
- (2) Study all existing funding sources and expenditures concerning bus transit in central Indiana.
- (3) Study the use of the public mass transportation fund established by IC 8-23-3-8.

- (4) Study the ridership numbers of the public transportation corporations serving Marion County.
- (5) Study ways to improve bus service in central Indiana, including improvements to the types of buses used and whether bus routes should be changed.
- (6) Study the extent to which bus transit systems can be supported by the users of bus transit systems.
- (7) Study the feasibility of entering public-private partnerships to expand bus transit.
- (8) Study whether tax credits for employers and employees who use bus transit will expand the ridership of bus transit systems.
- (9) Study the feasibility of light rail transportation, routes for light rail, and potential funding sources for, and impacts of providing, light rail transportation.
- (10) Identify ways in which private enterprise may provide transportation options in central Indiana.
- (11) Study the feasibility of using public-private partnerships for purposes of public transportation.
- (12) Study the issue of whether a referendum should be used in the process of establishing a transit district and, if a referendum should be used in the process, when the referendum should occur, and make recommendations to the general assembly on these issues, which may not include a recommendation for the holding of referendum before November 2014.

 - (a) The amount of the fee and whether it should be based on gross vehicle weight, including the treatment of motor vehicles that are base registered in Indiana under the terms of the International Registration Plan.
 - (b) The collection of the fee.
 - (c) The use of the fee revenue. (These topics were assigned to the Interim Study

Committee on Road Impact Fees by HEA 1324 but have been reassigned to the Joint Study Committee on Transportation and Infrastructure Assessment and Solutions.)
