Re: Student Instructional Expenditure Report for 2012-13 School Year

Per IC 20-42.5-3-5, the 2012-13 Student Instructional Expenditure Report provides analysis of school corporation expenditures reported to the Indiana Department of Education. Total expenditures in 2012-13 were \$11.489 Billion (a decrease of roughly \$89 Million from 2011-2012), of which \$6.611 Billion was spent on Student Instruction. The statewide Student Instructional Expenditures ratio (also known as the “Dollars to the Classroom” percentage) in 2012-13 was **57.5%**.

This figure is lower than 2011-12 (58.0%), and two full percentage points lower than that of the baseline year of 2005-06 (59.6%). Of 355 school corporations and charter schools, 165 (or 46%) increased their percentage of dollars to the classroom from 2011-12 to 2012-13. IC 20-42.5-3-5 also requires that expenditures be organized by nine geographic Education Service Centers, which provide school corporations access to cooperative purchasing, professional development, and technological services. Out of nine Educational Service Center areas, two increased their percentages.

Student Instructional Expenditures are defined as the sum of two categories: *1-Student Academic Achievement* and *2-Student Instructional Support*. Non-Instructional Expenditures consist of the remaining two categories: *3-Overhead and Operational* and *4-Non-Operational*. The definitions of the four categories of expenditures are as follows:

- **Student Academic Achievement:** Defined as the activity between teachers and students. This category includes those direct expenditures related to instruction, providing instruction, instructional materials, and instructional supervision. Activities dealing directly with the teaching of pupils, including teachers (salaries and related fringe benefits), teacher aides, educational media services, textbooks, and instructional technology are included.
- **Student Instructional Support:** This category includes other expenditures for those services that support student academic achievement within the school building. Pupil support

services included in these expenditures are attendance, social work, guidance, health, psychology, speech pathology, audiology, and school administration.

- Overhead and Operational: This category includes expenditures for non-instructional operating costs. Areas included are corporation administration, fiscal services (budgeting, payroll, and accounting), operation and maintenance of facilities, security, pupil transportation, food services, purchasing, and administrative technology.
- Non-Operational: This category includes expenditures that are not related to the day-to-day operation of public elementary and secondary education. Expenditures included in this category are facilities acquisition and construction, purchase of non-instructional equipment, and debt service obligations.

At the request of the State Board of Education, the Office of Management and Budget reviewed historical trends by object codes and accounts. In response, the following trends were identified for either significant change in overall dollars expended or percentage increase/decrease from 2009 to 2013:

- Positive Five Year Trends:
 - Building expenses decreased by \$51.7M (-20%)
 - Heating and Cooling for Building – Gas expenses decreased by \$38.6M (-41%)
 - Purchased Property Services: Construction Services expenses decreased by \$25.9M (-9%)
 - Equipment expenses decreased by \$20.7M (-15%)
- Concerning Five Year Trends:
 - Debt Service Payments Against Principal increased by \$84.3M (11%), Interest on Bonds or Note Payments increased by \$15.3M (5%), and Official Bond Premiums increased by \$2.3M (71%)
 - Food Purchases have increased by \$29.7M (19%)
 - Non-Student Instructional, Professional and Technical Services expenses increased by \$21.5M (20%)
 - Gasoline expenses increased by \$17.5M (34%)
 - Expenses on Non-Teacher, Public Employee Retirement increased by \$16.9M (26%)
 - Bank Service Charges increased by \$852 Thousand (54%)

Although there are some individual success stories, the overall regression in driving dollars to the classroom is concerning. School corporations are encouraged to take advantage of savings opportunities, such as joining the State's (or another consortium's) health insurance plans. Since 2010, fifteen school corporations have joined the State's health insurance plan, saving more than \$5.5 Million in total. Schools should also register at www.k12indiana.com to take advantage of consolidated purchasing contracts with neighboring schools or members of the designated education service center. Shared purchasing agreements are particularly amenable to furniture, office and classroom supplies, janitorial services, human resource and accounting services, and IT hardware and software purchases. It is hoped that parents and taxpayers will review these results and persuade school boards and administrators to improve performance over time.



