
**OUCC's FIRST MOTION TO MODIFY THE PROCEDURAL SCHEDULE
(No Objection)**

The Indiana Office of Utility Consumer Counselor ("OUCC"), by counsel, respectfully moves to modify the Procedural Schedule in this Cause. In support of its motion, the OUCC states as follows:

1. Pursuant to the October 21, 2009 Pre-Hearing Conference Order and by agreement of the parties, the OUCC's pre-filed testimony is due on January 5, 2010. Petitioner's rebuttal testimony is due on January 15, 2010, and the final hearing is scheduled for January 27, 2010.
2. The OUCC has recently learned the Indiana State Board of Accounts has conducted an audit of the Petitioner and is expected to issue an Audit Report within the next 4-6 weeks.
3. Review of the State Board of Accounts' Audit Report may raise additional issues relevant to this Cause.
4. As the Audit Report is not expected to be released until the end of January, the OUCC requests additional time in order to prepare its Prefiled Testimony, which would necessarily require the dates for the Petitioner's Rebuttal Testimony and the Final Hearing to also be modified.
5. The OUCC and the Petitioner have agreed to confer during the week of January 4, 2010 and will propose a revised Procedural Schedule to the Commission by January 8, 2010.
6. Counsel for the OUCC has contacted Petitioner's Counsel, Michael B. Cracraft, and he has stated his client has no objection to this Motion.

WHEREFORE, the OUCC respectfully requests additional time for the filing of its Case-In-Chief Testimony and to present a modified procedural schedule to the Commission as outlined above.


