**JOINT MOTION TO MODIFY PROCEDURAL SCHEDULE (AGREED)**

The Indiana Office of Utility Consumer Counselor (OUCC) and the City of Anderson, Indiana (Petitioner) (collectively, the Movants), by counsel, respectfully move to modify the procedural schedule in this Cause. In support of its Motion, the Movants state as follows:

1. Petitioner filed its case-in-chief on July 2, 2014. Pursuant to the Commission's docket entry issued on November 6, 2014, the OUCC was set to file its case-in-chief on November 10, 2014. Petitioner's rebuttal filing date was set for November 24, 2014.


2. On Monday, November 10, 2014, the Movants notified the presiding officer in this Cause that they have reached a settlement in principle that would resolve all issues. In order to allow the Movants time to reduce the settlement in principle to a written agreement with supportive testimony, the Movants request a modification to the procedural schedule. The Movants request that settlement testimony from each party be filed no later than November 21, 2014.

3. The evidentiary hearing in this Cause has been scheduled for December 10 and 11, 2014. The Movants request that the evidentiary hearing be converted to a settlement hearing to take place on December 10, 2014.

4. Counsel for the OUCC has agreed the procedural schedule should be so modified.

WHEREFORE, the Movants request the Commission modify the procedural schedule in this Cause to allow for the submission of settlement testimony from the Movants no later than November 21, 2014. The Movants further request that the evidentiary hearing set for December 10 and 11, 2014 be converted to a settlement hearing to take place on December 10, 2014.
