PROCEDURAL SCHEDULE**

1. The February 26, 2015 Memorandum issued by IURC Staff indicated the OUCC should file its report on May 11, 2013.

2. On May 1, 2015, Deerfield Estates, Midwest Warehousing, and R&R Plastics jointly filed a petition to intervene in this cause and asked for the convening of a prehearing conference.


3. The OUCC believes the interveners will seek authority to file cases. The OUCC further considers it possible Applicant may seek to or be required to file a case-in-chief or other supplemental filing.


