Re: Formal Complaint 15-FC-40; Alleged Violation of the Open Door Law and Access to Public Records Act by the Fire Department of Liberty Township, Inc.

Dear Mr. McClure,

This advisory opinion is in response to your formal complaint alleging certain members of the Fire Department of Liberty Township, Inc., ("FDLT") violated the Open Door Law ("ODL"), Ind. Code § 5-14-1.5-1 *et. seq.*, and the Access to Public Records Act ("APRA") Ind. Code § 5-14-3-1 *et. seq.* FDLT has responded via counsel, William S. Frankel, IV, Esq. The response is enclosed for your review. Pursuant to Ind. Code § 5-14-5-10, I issue the following opinion to your formal complaint received by the Office of the Public Access Counselor on January 30, 2015.

#### **BACKGROUND**

Your complaint dated January 30, 2015 alleges the FDLT excluded you from a special meeting in violation of the Open Door Law.

On January 27, 2015, the FDLT held a "special meeting" to discuss "the Chief Process, disciplinary actions, and the future of the FDLT". The FDLT responded to your complaint arguing that the purpose of the meeting was to discuss the threatened and pending litigation you filed against them as well as a disciplinary action. It also concedes the notice was statutorily insufficient yet unintentional.

### **ANALYSIS**

Opinion of the Public Access Counselor 15-FC-21 is incorporated by reference. As I noted in that particular Opinion, notice requirements for executive sessions can be found at Ind. Code § 5-14-1.5-6.1(d) and must state the specific statutory authorization allowing the executive session (48) forty-eight hours in advance of the meeting.

The notice provided was indeed insufficient; however, as I stated in the former Opinion, it appears as if the FDLT is just now orienting itself to the requirements of the Open Door Law. While ignorance of the statute is not a defense and a violation has occurred, it is my sincere hope the FDLT will abide by the strict requirements of the ODL in the future.

### **CONCLUSION**

For the foregoing reasons, it is the Opinion of the Public Access Counselor the Fire Department of Liberty Township has violated the Open Door Law.
