<u>Renew Online</u>: Go to <u>www.pla.in.gov</u> and select the License Express link. Your Login ID is your primary license number. Password is the last four digits of your social security number. You can update your address and other demographic information during the renewal or any other time by logging in to your records online.

- Tax Lien Information: If a tax protest has been recorded on your license according to the Indiana Department of Revenue, your license may not be renewed until this agency receives written confirmation that the tax protest has been removed by the Indiana Department of Revenue.
- Active Status: If your current license status is "Active", and you wish to renew under that same status, and have been licensed as a Trainee Appraiser for more than five years you must have completed twenty-eight (28) hours of continuing education from Real Estate Appraiser Licensure and Certification Board approved sponsors pursuant to IC 25-34.1-3-8(g) and 876 IAC 3-5-1. If you hold an "Active" license and have not completed the continuing education requirements necessary to renew the license in "Active" status, you must renew your license under the "Inactive" status.
- Inactive Status: If your current license status is "Inactive", you must renew the license under that same status.
