If this brochure has been printed out for you, or if for any reason you are not able to reach the service agencies, please contact the State Information Center. We will be happy to provide you with additional assistance.

The State Information Center provides a single point of entry into State government, making State programs and services more easily accessible. With 38,000 employees, over 70 State agencies and more than 800 work site locations, State government can be confusing. The State Information Center was created to improve customer service to Hoosier residents by helping them navigate the service highway.

If you call or email us, you will work with an Information Counselor who is trained in all aspects of State government operations. They are also trained to assess each requester’s need and to match the need to the appropriate program or service. Counselors can help with more than the issues that relate just to State agencies. They can also direct callers to appropriate federal and local government agencies.

## Driver Information

### Bureau of Motor Vehicles

---

#### Branch Locations

The Indiana Bureau of Motor Vehicles (BMV) has many branch locations around the state. They also provide many services on-line and at express terminals. #### Driver License

New residents must obtain a valid driver license within 60 days of moving to Indiana. For licensing purposes, you are considered an Indiana resident - even if your legal residence is in another state - for the following reasons:

- You have resided in Indiana for over half a calendar year (except college students and active members of the military).
- You are registered to vote in Indiana.
- You have a child enrolled in the Indiana school system.

You must take proof of identity to get your license. Please see the Proof of Identity section below. For more information about driver licenses, or to get a copy of the Driver License Manual, visit [www.IN.gov/bmv/driverlicense](http://www.IN.gov/bmv/driverlicense).

#### State Identification (non-driver)

BMV offers State Identification cards for persons of any age who are non-drivers. The card looks similar to a standard driver license except that it is clearly marked "Non-driver ID" at the top.

#### Proof of Identity to Obtain Driver License or State Identification

If you are making an application for an Indiana driver license, permit or identification card, you will be required to provide proof of your identity. The BMV has joined many other states in revising its driver license policy to enhance the security of our driver license system. This policy requires more documentation and is intended to prevent identity fraud. Only original documents or those certified by the issuing agency will be accepted. Driver

licenses are accepted all over the country as an indicator of a person's identity. It is very important that we protect your identity by making our system as secure as possible.

To preserve the integrity of the driver license for identification purposes, the BMV has established guidelines of acceptable forms of proof of identity, which includes name, date of birth, Indiana residency and Social Security number. ### Vehicle Title and Registration

New residents must title and register all vehicles within 60 days of moving to Indiana. To title the vehicle, you will need the following documents:

- The title document from your previous state of residence, proof of Social Security Number and a statement from a law enforcement officer (local marshal or police, county sheriff or state trooper) affirming that the vehicle identification number (VIN) is the same on the vehicle and the out-of state title.

To register the vehicle (to receive a **license plate**), you will need to take the following documents:

- The vehicle title, and
- Insurance information.

## Voter Information Election Division

---

The Indiana Election Division comes under the direction of the Office of the Secretary of State. It also is governed by the bipartisan Indiana Election Commission (IEC). The Division is responsible to all voting constituencies: election and voter registration professionals, office holders, candidates, committee chairs, campaign treasurers and voters.

### Voter Information

In order to vote in Indiana, a person must first register. The following items constitute voter eligibility. A person must:

- Meet standards established by both the United States Constitution and the IEC;
- Be at least eighteen (18) years of age;
- Be a United States citizen; and
- Be a resident of the precinct for at least thirty (30) days prior to the election.

The Division contracts with managed care providers who provide an array of care for individuals who meet diagnostic, functioning level and income criteria. The managed care providers provide a year's care at the most appropriate level for all enrollees.

Persons targeted for Division funding are:

- Adults with serious mental illness,
- Children and adolescents with serious emotional disturbance, and
- Persons of all ages with chronic addictive disorders.

## Utilities

### Utility Regulatory Commission

---

The Indiana Utility Regulatory Commission (IURC) has regulatory responsibility over natural gas, water, private sewer, electric and telephone services. The IURC regulates more than 700 utilities; it does not regulate municipal sewer utilities.

An advocate of neither the public nor the utilities, the IURC is required by state statute to make decisions that balance the interests of all parties and to ensure the utilities provide adequate and reliable service at reasonable prices. The Commission regulates various aspects of the public utilities' business including rates, financing, bonding, environmental compliance plans, service territories, construction projects, and acquisition of additional plants and equipment. The Commission has authority to initiate investigations of all utilities' rates and practices.

#### Applying for Utility Service

If you need to set up an account for residential service for any utility, you must contact the utilities in your home community. Check your local telephone directory.

#### Energy Assistance Program

Indiana does have energy assistance programs - separate from the IURC - to provide financial assistance to low-income households. The intent is to maintain utility services during the winter heating season. For information, contact your local Community Action Agency. ## Buying a Home Housing Finance Authority

---

The Indiana Housing Finance Authority (IHFA) is a state-operated bank that finances residential mortgages and the development of rental housing. IHFA serves also as a community development organization. IHFA is financially self-sufficient; no state taxes are used for operating support.

### Home Ownership

IHFA provides down payment assistance and low interest rate mortgages. These programs are primarily administered through a network of lenders participating in the Homeownership Lending Programs, covering all 92 counties in the state. In addition to a long involvement in the Rental Housing Tax Credit Program, IHFA has taken on the responsibility of a Participating Administrative Entity for the State of Indiana. In that responsibility, IHFA is playing a direct role in finding solutions to the problem of high rents in subsidized properties.
