Subject: Indiana Federal Grants Report - Federal Fiscal Year (FFY) 2021

Pursuant to IC 4-3-24-7, the State Budget Agency is required to publish an annual report summarizing the federal assistance received by state agencies for the relevant federal fiscal year. This report details the federal grant awards received by state agencies for FFY 2021. Unless indicated otherwise, all data for this report was pulled from the state's accounting system.

In FFY 2021, state agencies received 464 federal grant awards for a total of \$25.6 billion, with \$5.2 billion in corresponding matching obligations. The largest award was approximately \$12.2 billion for Medicaid Payment Assistance. The second and third largest awards were just over \$3 billion for American Rescue Plan State and Local Fiscal Recovery Funds and \$1.996 billion for Elementary and Secondary School Emergency Relief Funds. In total, the State received just over \$8.56 billion in various grants for COVID-19 related funding.
