TO: THE INDIANA STATE RECOUNT COMMISSION

Pursuant to Indiana Code 3-12-10-8, we have reviewed the ballots cast in the 2016 Primary Election conducted on May 3, 2016, for the petitioned precincts in Indiana Senate District Thirty-Six. Our review was conducted in accordance with the Guidelines for Conduct of an Election Recount and Contest as Amended, dated April 29, 2016, and State Recount Commission Amendments to Recount Guidelines, Order 2016-07.

Our activities did not include a review of the voting systems used in the election. We have relied on the requirements set forth in Indiana Code 3-11 to provide for the appropriate review of the systems.

The accompanying schedule shows the ballots returned by Marion and Johnson Counties, undisputed valid ballots tallied by the State Board of Accounts, the disputed valid ballots tallied by the State Board of Accounts, the invalid ballots tallied by the State Board of Accounts, and the disputed invalid ballots tallied by the State Board of Accounts. The schedule presented was prepared using Marion and Johnson Counties' computation of distributed votes by precinct. This computation was prepared using county records that were supplied to us during the recount. The second schedule presented for Johnson County was prepared showing the tallying by vote centers to reflect Johnson County's actual election night process.

The election results as certified by Marion and Johnson Counties were as follows:
