- (4) Total is \$154 if you are collecting the sheriffs service of process fee of \$13
- (5) As of July 1, 2015 the amount is reduced to \$5.
- (6) Add \$50 mortgage foreclosure counseling and education fee for all mortgage foreclosure actions filed May 10, 2013 through December 31, 2014.
