- Online / Paper-Pencil Testing
 - ISTEP+ Part 1
 - ELA, Science, Social Studies
 - IREAD-3
 - Schools may choose online or paper/pencil testing
- PearsonAccess^{next}
 - Pearson's administration portal
 - December 7-11
 - CTCs indicate testing mode (ISTEP+ Part 1, IREAD-3)

- Determining capacity/connectivity:
Pearson Technology Readiness Process
 - System Set-up
 - Device Inventory
 - Local Infrastructure Trial
 - Statewide Readiness Test
 - Scheduled to occur on January 12, 2016

Charter	97	55 / 56.7%
Accredited Nonpublic	344	229 / 66.6%

Only 3 school corporations chose not to participate in the program.
