ICSB Authorized Charter Schools: Academic Results ILEARN Grade 3-8 Proficiency and Growth; IREAD 3 Proficiency (2022-23)

The ILEARN assessment in its current form, representing a new type and mode of assessment (adaptive and online-only) than the previous ISTEP assessment, was administered for the first time during the 2018-19 SY. No assessment was administered in the 2019-20 SY due to the Covid-19 pandemic. In 2023, the Indiana General Assembly passed HEA 1591, directing the State Board of Education ("SBOE") to assign null or no letter grades to all schools for the 2022-23 school year, marking the fifth time since the 2017-18 school year that schools have been "held-harmless" from consequences for academic performance. Proficiency percentages are calculated using all tested students, regardless of the number of days a student attended the school. Growth percentages are determined for grades 4-8 only and represent the percentage of students meeting their growth target. More academic data for each school may be found on the school's School Performance Dashboard on the Indiana Graduates Prepared to Succeed ("GPS") Program Tool.

ICSB Authorized Charter Schools: Academic Results SAT Proficiency, Graduation Rate, and Diploma Type (2022-23)

SAT replaced ISTEP 10 as the state mandated HS assessment beginning with the 2021-22 SY, and is required for all students in grade 11 beginning with the 2023 graduating cohort. SAT Benchmark percentages for EBRW and Math represent students tested in Grade 11 as first-time test takers and as the graduating cohort of 2023. Adult High Schools ("AHS") enroll students who are over the age of 18, under credited, dropped out of high school, and are typically out of cohort from their originally projected graduation year. Only those enrolled AHS students who elect a specific graduation pathway and intend to enroll in post-secondary education take the SAT as AHS do not have a "traditional" grade 11. Because graduation rate is calculated at the end of the school year regardless of the length of time a student is enrolled at a school, the graduation rate for an AHS is not comparable to the graduation rate for a traditional public high school. ICSB Authorized Charter Schools: Academic Results Adult High Schools (2022-23)

The State's adult high school ("AHS") accountability system calculates the grade of an AHS as the sum of the school's weighted graduation calculation score and its weighted college and career readiness score. The graduation calculation is made up of the school's graduation to enrollment percentage (the number of students who graduated during the school year divided by the school's within-year-average number of students, multiplied by four), the school's graduation rate, and the school's graduation qualifying exam passing rate. The College and Career Readiness ("CCR") Rate is the percentage of graduates in the school year who achieved certain AP or IB scores, earned dual college credit, or obtained certain industry certifications, multiplied by .8. Because all Adult High Schools ("AHS") were placed in a "No Grade" category by SBOE, IDOE did not calculate either the weighted graduation calculation or college and career readiness score for the 2022-23 SY. The number of graduates represents all students reported on the DOE-GR (Graduate Report) at the end of the 2022-23 SY reporting period.

ICSB Authorized Charter Schools: Student Enrollment Data

PE Enrollment data is obtained from IDOE's DOE-PE (Annual Pupil Enrollment Count) report. This report is used to determine demographic data. Beginning with the 2020-2021 school year, attendance reporting and calculation changed for all public schools across the State of Indiana. Student attendance data is now submitted DAILY to IDOE aligned to the reported school calendar and calculated by IDOE based upon individual student daily attendance and the 94% calendar threshold requirement. The attendance listed is the traditional average attendance rate for the school. Adult High School students over the age of 18 are not mandated to attend by state statute but do so to earn credits required to obtain their High School Diploma. *The 22-23 Primary Instructional Mode is not a requirement of the Annual Report, but ICSB deems it relevant for comparison purposes to the most recent annual reports.
