WHEREAS, the Vanderburgh County Vote Center Plan was duly adopted by the Vanderburgh County Election Board, pursuant to Ind. Code § 3-11-18.1-3, with an initial effective date of August 12, 2011;

WHEREAS, Ind. Code § 3-11-18.1-15 authorizes Vanderburgh County to amend its Vote Center Plan, previously adopted under Ind. Code § 3-11-18.1-3, by the unanimous vote of the entire membership of the board approving the plan amendment;

WHEREAS, certain of the vote center locations previously approved as part of the Vanderburgh County Vote Center Plan are no longer available to hosting a vote center on Election Day;

WHEREAS, the Vanderburgh County Election Board has determined that it is in the best interests of the community and, therefore, desirable to provide a variety of geographically dispersed vote center locations, including additional locations intended to replace certain prior vote center locations which are no longer in use;

WHEREAS, early voting at satellite voting locations has proven to provide an efficient, effective, and popular manner for residents of Vanderburgh County to vote in elections, and the Vanderburgh County Election Board desires to continue the use of such satellite voting locations; and

WHEREAS, the Vanderburgh County Election Board so approves the Amendment of the Vanderburgh County Vote Center Plan, in and for Vanderburgh County, Indiana, as set forth herein;

BE IT, THEREFORE, ORDERED BY THE VANDERBURGH COUNTY ELECTION BOARD,
THAT:

The Election Day Vote Centers identified in Exhibit "B" attached hereto and made a part hereof by this reference are to be open on Election Day, from 6:00 a.m. to 6:00 p.m., in Vanderburgh County, Indiana.

The Vanderburgh County Election Board hereby adopts this Order to approve the Amendment of the Vanderburgh County Vote Center Plan.

This Order shall take effect immediately and may only be rescinded by the unanimous vote of the entire membership of the Vanderburgh County Election Board.

CERTIFICATION OF ACCESSIBILITY

Pursuant to Ind. Code § 3-11-18.1-4(15), the Vanderburgh County Election Board hereby unanimously certifies that all Early Voting Vote Centers and Election Day Vote Centers designated in connection with this Amendment of the Vanderburgh County Vote Center Plan comply with the accessibility requirements applicable to polling places under Indiana Code 3-11-8.
