WHEREAS, the Vanderburgh County Vote Center Plan was duly adopted by the Vanderburgh County Election Board, pursuant to Ind. Code § 3-11-18.1-3, with an initial effective date of August 12, 2011;

WHEREAS, Ind. Code § 3-11-18.1-15 authorizes Vanderburgh County to amend its Vote Center Plan, previously adopted under Ind. Code § 3-11-18.1-3, by the unanimous vote of the entire membership of the board approving the plan amendment;

WHEREAS, certain of the vote center locations approved as part of the original Vanderburgh County Vote Center Plan are no longer amenable to hosting a vote center on Election Day;

WHEREAS, the Vanderburgh County Election Board has determined that it is in the best interests of the community and, therefore, desirable to provide a variety of geographically dispersed vote center locations, including additional locations intended to replace certain original vote center locations which are no longer in use; and

WHEREAS, the Vanderburgh County Election Board so approves the Amendment of the Vanderburgh County Vote Center Plan, in and for Vanderburgh County, Indiana.

BE IT, THEREFORE, ORDERED BY THE VANDERBURGH COUNTY ELECTION BOARD, THAT:

The following Vote Center locations are to be open on Election Day, from 6:00 a.m. to 6:00 p.m., in the City of Evansville, Vanderburgh County, Indiana:


