

WABASH COUNTY ELECTION BOARD
VOTE CENTER PLAN AMENDMENT #1

WHEREAS, the Wabash County Vote Center Plan was duly adopted on February 28, 2013; and

WHEREAS, Indiana Code 3-11-18.1-15 authorizes Wabash County to amend a plan adopted under 3-11-18.1-3 by unanimous vote of the entire membership of the board approving the plan amendment; and

WHEREAS, the Wabash County Election board has determined that the vote center plan previously adopted should be amended to reflect a change for two (2) vote center sites; and

WHEREAS, the Wabash County Election Board so approves the Wabash County plan amendment for vote centers in Wabash County, Indiana.

BE IT THEREFORE ORDERED BY THE WABASH COUNTY ELECTION BOARD:

1. The following two (2) locations will **no longer** be used as vote centers sites effective with the November 4, 2014 general election:


