Caseload

36,846 families and 64,503 children were authorized for this period.
123 of the above families and 232 of the children had TANF priority.
1 of the above families and 4 of the children had an AJS TANF-Impact referral.
43 of the above families and 88 of the children had a non-AJS TANF-Impact (Working Families) referral.
6 of the above families and 12 of the children had a SNAP (Working Families) referral.
6,928 of the above families and 7,104 of the children participated in the On My Way Pre-K program.
140 of the above families and 171 of the children had vouchers with CCDF Contract Centers.
5,629 of the above families and 8,807 of the children either had Homeless priority or identified as such.*
1,089 of the above families and 2,111 of the children had one or more disabled children in the household.*
0 of the above families and 0 of the children were in a household with family members in the military.*
0 of the above families and 0 of the children were part of a household with over \$1,000,000 in assets.*
1,411 families and 2,259 children were on wait lists at the end of the period.

Children

64.1 % of children were served in licensed care.
0.8 % were cared for by relatives.
Infants (under 1 year of age) constitute 5.3 % of all children served.
Toddlers (ages 1 to 2 years) constitute 22.2 % of all children served.
Children ages 3 to 5 years constitute 40.0 % of all children served.
Kindergarten-age children (age 5 years) constitute 0.4 % of all children served.
School-age children (ages 6+ years) constitute 33.7 % of all children served.
0.1 % of children had part-time vouchers.
5.7 % of children had vouchers for shift 2 care.
Children of Hispanic or Latino Ethnicity accounted for 9.5 % of all children served.
Race codes: African American: 52.8 %; White: 34.7 %; American Indian / Alaskan: 0.6 %; Asian: 0.9 %;
Hawaiian / Pacific Islander: 0.2 %; Multiple Races: 7.0 %
An average of 14.2 weekly hours were authorized for school-age children.
There were 5 new TANF-Impact referral children (5 families) added this period.
There were 1 new SNAP-Impact referral children (1 families) added this period.

Families

94.0 % of families received subsidies because of employment.
24.9 % of families had copayments, at an average of 8.6 % of income.
35.3 % of families had overages, at an average of 17.6 % of income.
The average family size was 3.6 and the average number of children served per family was 1.8.
88.6 % of families were headed by a single parent.
0.3 % of families were marked as TANF recipients and 0.9 % listed TANF as a source of income.
0.0 % of families were marked as SNAP referral recipients and 40.7 % listed SNAP as a source of income.
64.1 % of families were below the poverty level. 18.5 % of families were above 127 % of the poverty level.

Expenditures

The average cost of care for a month per child during this period was \$914 (subsidy + copay + overage).
Parents paid 14.8 % of the cost (3.6 % in copayments and 11.2 % in overages) and the program paid 85.2 %.
Average monthly expenditures for children under 1 year of age were \$1,277.
Average monthly expenditures for school-age children (ages 6+ years) were \$634.
78.7 % of total expenditures were for children under 6 years of age.

County Stats

Marion County accounted for the largest porportion of families served with 33.4 % of the caseloads.
The highest average cost of care was in Newton County at \$1,564 per child.
The lowest average cost of care was in Washington County at \$468 per child.
Jay County and others had the greatest proportion of children served in licensed care at 100.0 %.
Rush County had the greatest proportion of children served in LLEP care at 56.0 %.
Whitley County ranks first in relative care statewide with 8.3 % of all children cared for by relatives.
Crawford County and others had the highest % of families with a service need of employment at 100.0 %.
Pike County had the greatest proportion of TANF recipients, where 4.5 % of families receiving child care subsidies also received TANF income.
Martin County had the greatest proportion of SNAP recipients, where 63.2 % of families receiving child care subsidies also received SNAP/Food Stamps income.
