Pursuant to the Courts inherent authority to establish bonds for the purposes of

securing the personal appearance of persons before the Court the following bond schedule

shall apply:

Class D Felony	None	\$1,500.00
*Class A Misdemeanors	None	\$ 750.00
OWI-A Misdemeanors	None	\$1,500.00
Resisting Law Enforcement A/M	None	\$1,000.00
Control Substance A/M	None	\$1,500.00

Crimes of domestic violence—A person charged with a crime of domestic violence as defined by I.C. 35-41-1-6-3 shall be kept in custody and not released on bail for at least 24 hours from the time of arrest pursuant to IC. 35-33-1-1.7 and I.C. 35-33-8-6.5.

### DOUBLE BONDS

All bonds double where the following conditions exist:

- The person has preexisting charges in any Court.
  - The person is on probation.
- 

Persons whose identity cannot be positively identified at booking shall be held without bond until the person is brought before the Court. This includes persons, who refuse to cooperate in their identification but not limited to, those by refusing to be finger printed, individuals who possess conflicting identification and individuals whose identifying information cannot be verified.

Community Correction detainees (home detention-electronic monitoring) shall not be released on bond and held to the next available opportunity to appear before the Court.

### TRIPLE BONDS


All bonds triple where the defendant is not a resident of the State of Indiana.

No defendant shall be released on bond unless there is a signed promise to appear properly filled out by the Clerk's Office or the Sheriff's Department.

This schedule supersedes all previous schedules.

This schedule is effective the 19th day of March, 2012.
