CIRCUIT COURT

BOND SCHEDULE FOR ORANGE COUNTY COURTS

NO BAIL (BOND) ALLOWED FOR THE FOLLOWING CIRCUMSTANCES

NO BAIL OFFENSES: Murder, Any Class A Felony, Any Class B Felony, Domestic Battery, Domestic Intimidation, Domestic Confinement, Domestic Invasion of Privacy, any violation of a protective order.

DETAIN FOR 8 HOURS AND SIGN "Agreement to Have No Contact with Alleged Victim" BEFORE ELIGIBLE FOR BOND (UNLESS COURT ORDERED OTHERWISE): Battery, Sexual Battery, Invasion of Privacy, Stalking.

A PERSON ARRESTED ON WARRANT FOR ANOTHER STATE (FUGATIVE ARREST WARRANT) IS NOT ELIGIBLE TO POST BOND.

A PERSON ARRESTED ON AN FTA WARRANT OR A PTR WARRANT IS NOT ELIGIBLE TO POST BOND.

A PERSON ON PROBATION OR ON BAIL FROM A PREVIOUS CHARGE THAT IS ARRESTED FOR THE COMMISSION OF A FELONY OFFENSE IS NOT ELIGIBLE TO POST BOND.

A PERSON CHARGED AS A HABITUAL OFFENDER OR WHO HAS TWO (2) PRIOR FELONY CONVICTIONS IS NOT ELIGIBLE TO POST BOND.

STANDARD BAIL REQUIREMENTS

CLASS C FELONY OFFENSES: Crimes against a person - \$2,500.00 Cash, \$15,000.00 Surety, \$30,000.00 Property, and a signed "No Contact" order.

CLASS C FELONY OFFENSES: Crimes against property - \$1,500.00 Cash, \$7,500.00 Surety, \$15,000.00 property.

CLASS D FELONY OFFENSES: \$1,000.00 Cash, \$3,750.00 Surety, \$7,500.00 Property.

CLASS A MISDEMEANOR OFFENSES: \$ 500.00 Cash, \$2,000.00 Surety, \$4,000.00 Property.

BOND IS DOUBLED IF THE FOLLOWING CIRCUMSTANCES APPLY

A Person is charged with Resisting Law Enforcement or Battery to a Police Officer

A Person resides out-of-state.

BAIL COMPUTATION

In the event that a person is arrested on more than one charge, the bail amount for the most serious offense shall be applied as the total bail amount required.

PRE-CHARGE
CRIMINAL BAIL SCHEDULE ORDER

Comes now the Court and having determined that it is now necessary and advisable to provide a schedule of bail for individuals arrested and being held at the Orange County Jail, and applicable only until formal criminal charges have been filed and a specific bail, set by the Court, IT IS THEREFORE ORDERED that effective immediately all previously established bail schedules of the Orange Superior Court are set aside and held for naught, and the following full cash only bails shall be accepted in Orange Superior Court cases unless and until a different bail has been, or is ordered in any specific case:

A. SINGLE COUNT CHARGES WITH DEFENDANT RESIDING IN ORANGE OR ADJOINING COUNTY

- (1) Misdemeanor O.W.I., .15% A.C.E. or .08 A.C.E. \$805.00
- (2) Misdemeanor Marijuana \$805.00
- (3) Misdemeanor or Class D Felony \$2,005.00*
Domestic Violence (including but not limited to Domestic Battery, Domestic Criminal Recklessness, Domestic Residential Entry, Domestic Criminal Mischief, Domestic Trespass, Domestic Intimidation, Domestic Stalking, and Domestic Invasion of Privacy)
- (4) Non Domestic Other Misdemeanor or Class D Felony Battery, Criminal Recklessness, Residential Entry, Criminal Mischief, Trespass Intimidation, Stalking, or Invasion of Privacy. \$1,005.00*

*Prior to being eligible to post bail, any individual arrested for a charge(s) listed in A.(3) or A.(4) above shall be detained at the Orange County Jail for eight (8) hours after that individual's arrival at the jail; and, after the expiration of the same, that individual shall be eligible to post bail if, and only if, he or she agrees in writing to initiate no contact with the alleged victim using the form entitled "Agreement to Have No Contact with Alleged Victim," which is attached hereto, made a part hereof, and marked Exhibit A. The original(s) of any such agreement(s) shall be retained at the jail, and shall be delivered to the Orange Superior Court no later than the first working day after the individual's release.

*Prior to being eligible to post bail, any individual arrested for a charge(s) listed in A.(3) or A.(4) above shall be detained at the Orange County Jail for eight (8) hours after that individual's arrival at the jail; and, after the expiration of the same, that individual shall be eligible to post bail if, and only if, he or she agrees in writing to initiate no contact with the alleged victim using the form entitled "Agreement to Have No Contact with Alleged Victim," which is attached hereto, made a part hereof, and marked Exhibit A. The original(s) of any such agreement(s) shall be retained at the jail, and shall be delivered to the Orange

Superior Court no later than the first working day after the individual's release.

C. SINGLE OR MULTIPLE COUNT CHARGES WITH DEFENDANT RESIDING OUTSIDE OF ORANGE OR ADJOINING COUNTY.

Determine Defendant's Bail Under A. and B. above and Double It.*

*Prior to being eligible to post bail, any individual arrested for a charge(s) listed in A.(3) or A.(4) above shall be detained at the Orange County Jail for eight (8) hours after that individual's arrival at the jail; and, after the expiration of the same, that individual shall be eligible to post bail if, and only if, he or she agrees in writing to initiate no contact with the alleged victim using the form entitled "Agreement to Have No Contact with Alleged Victim," which is attached hereto, made a part hereof, and marked Exhibit A. The original(s) of any such agreement(s) shall be retained at the jail, and shall be delivered to the Orange Superior Court no later than the first working day after the individual's release.

D. NOTICE TO APPEAR

Any individual released pursuant to this bail schedule shall execute a written notice to appear for initial hearing using the form entitled "Notice to Appear," which is attached hereto, made a part hereof, and marked Exhibit B. The individual released shall be given a copy of said notice, and the original shall be retained at the jail, and shall be delivered to the Orange Superior Court no later than the first working day after the individual's release.
