CARES ACT Fund

- \$234,016 total awarded to ISDH
- ISDH is prioritizing utilizing these funds for Emergency Financial Assistance throughout the state
- In order to move this out to agencies quickly and eliminate financial burden, ISDH has selected 3 agencies to direct funds to and serve as the regional hub for distributing funds to clients across the state

COVID-19 Updates

- Extended 90 Day Refill until June 15th, will re-evaluate after that
- 60 day extension for supporting documentation continues for MSP applications/re-certifications
- Income Qualifications- ISDH will exempt CARES Act payment stimulus check and \$600 Unemployment Supplement from income calculation, this will include future stimulus funds unless notified differently by HRSA
 - NMCMs should state in case notes that clients receive(d) these funds but per ISDH guidelines these forms of COVID-19 stimulus funds will not impact the ISDH eligibility for services.



COVID-19 Updates Continued

- Paycheck Protection Program (PPP)
 - If you applied, received, and used PPP funds, and it will impact your use of Ryan White funds during the current grant period, please contact ISDH staff.

Quality Reminder

- When client's addresses or contact information change please remember that making a change on CaseManager does not automatically get reflected on their Medical Services information or in HIVE.
- All changes that impact clients that are on a Medical Services program must be submitted to the Enrollment Specialist to account for changes through a Report of Change form, forms are found on HIVE.
- Changes should first be made in CaseManager, a Report of Change should be submitting to the ES where changes will be made in Medical Services databases and insurance carriers, following ISDH staff will work together to double check all systems.
