- PBM RFA – August 1

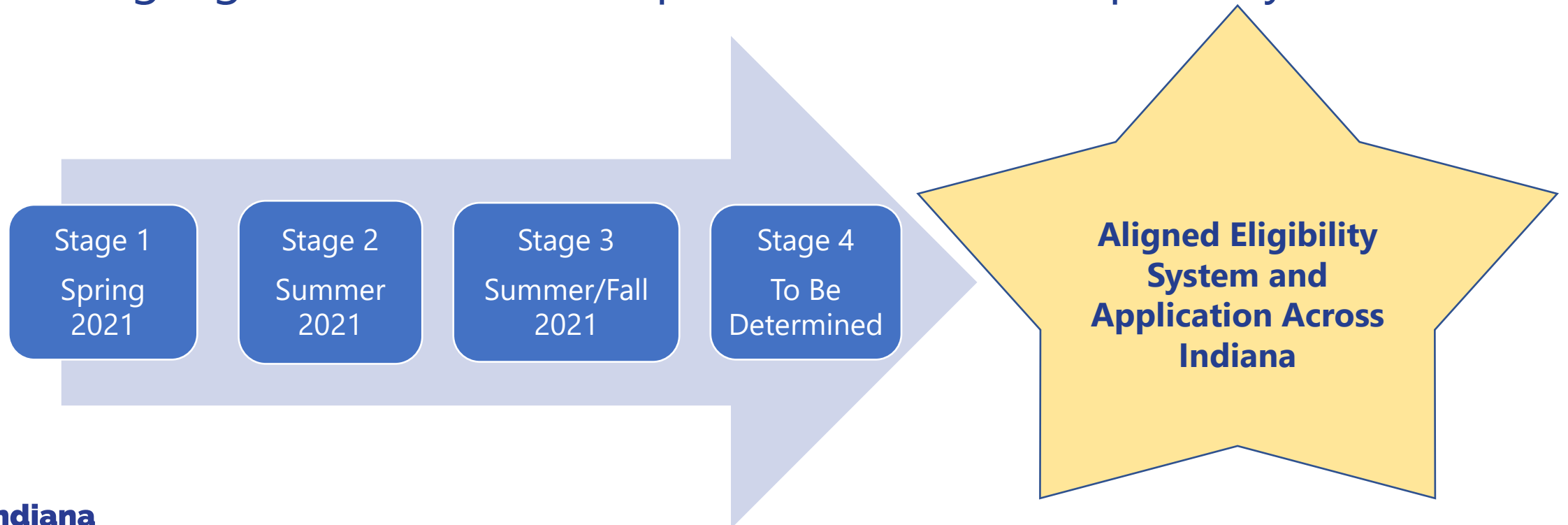

- HIV Services Program Manager – Jon Morgan leaving May 28 – Position Posted

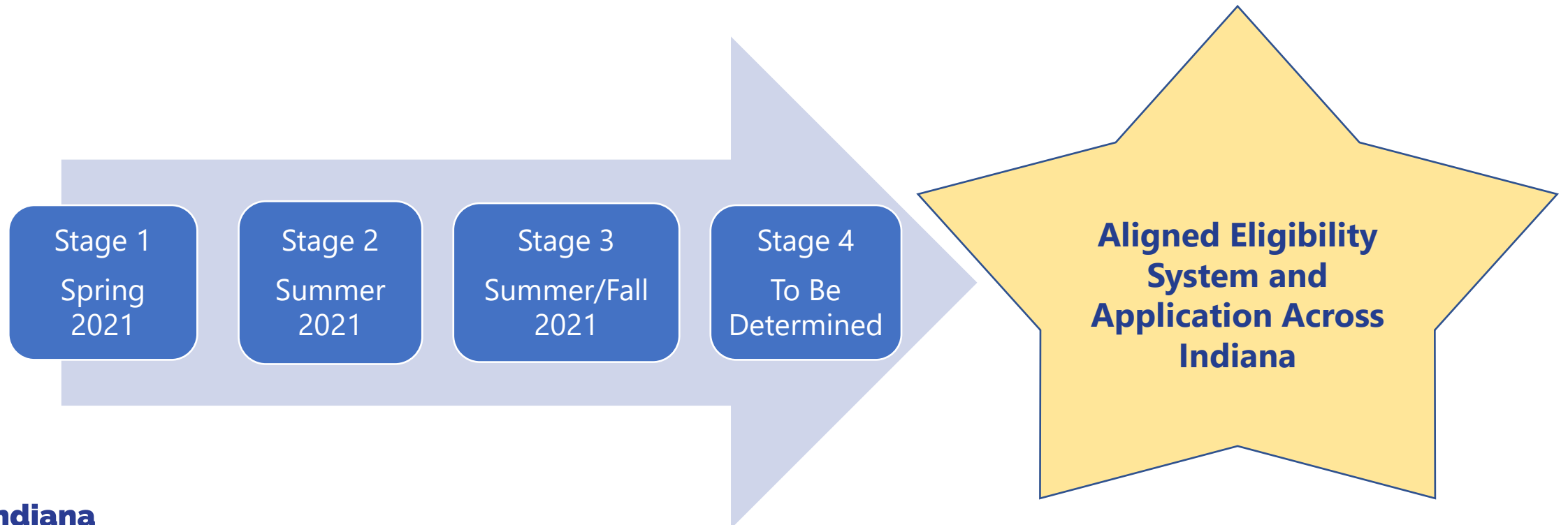
Eligibility Transition

- IDOH working through staged approach to evolving eligibility. Goal is to make changes that benefit clients and work towards strategic goals of consistent processes and transparency.



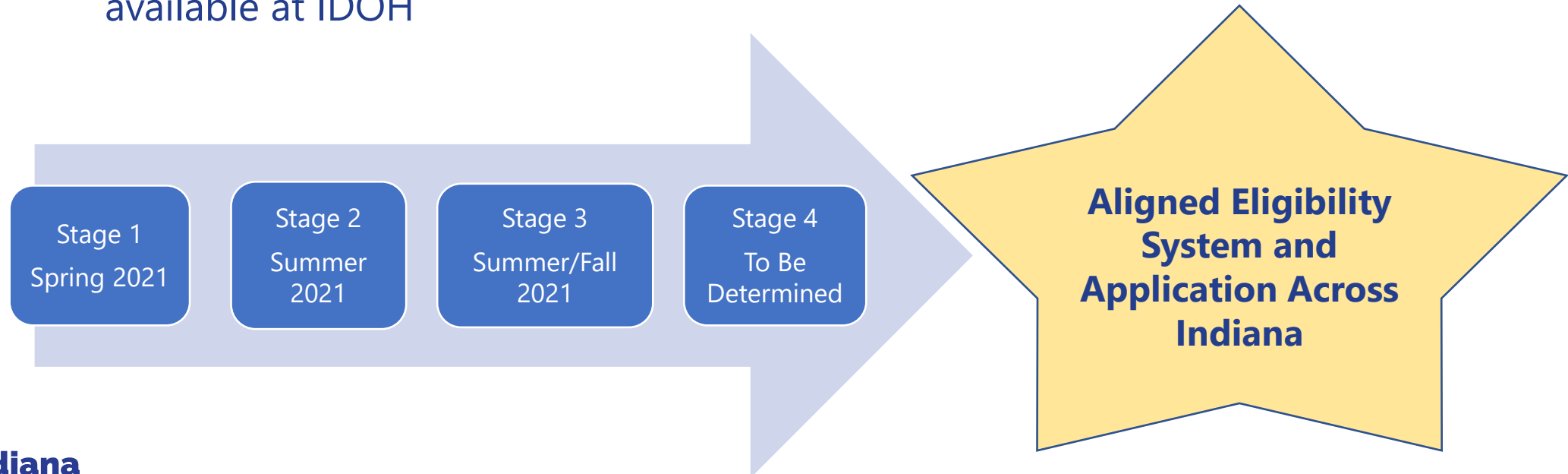
Eligibility Transition: Stage 1

April 2021 Integrate documentation requirements for MSP/HSP applications to be the same



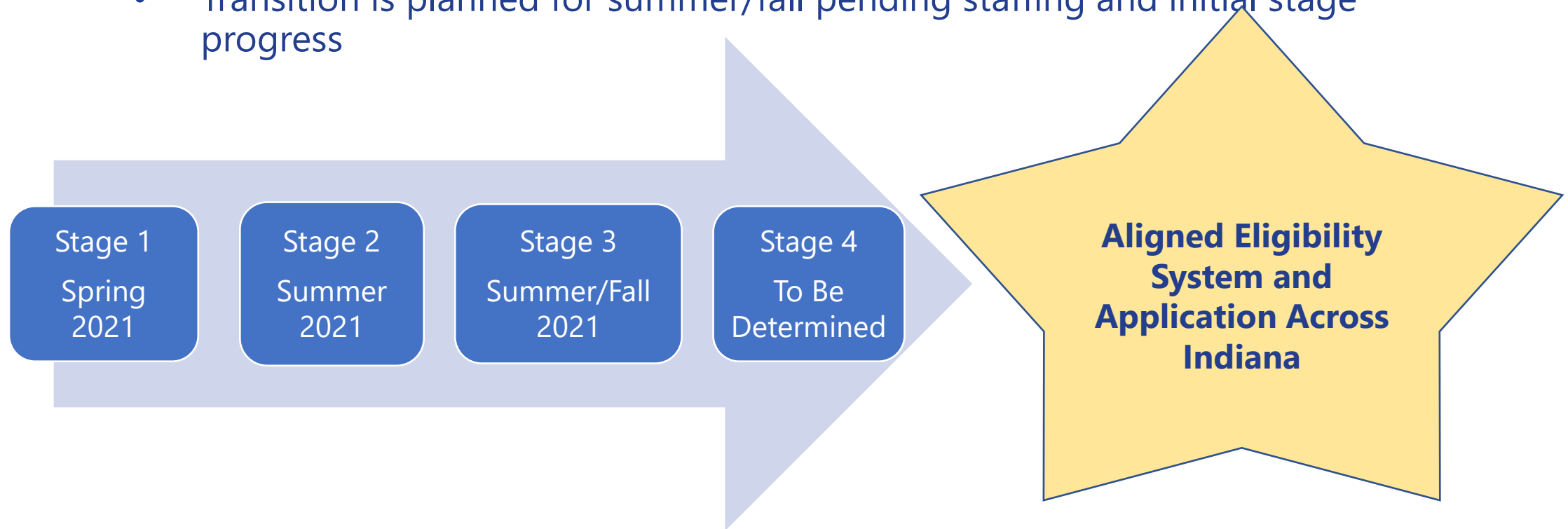
Eligibility Transition: Stage 2

- Summer 2021 MSP/HSP Integration to IDOH Ryan White Services
 - Enrollment Specialists will process all Ryan White applications
 - External Ryan White Medical Services Manual training and distribution
 - HIVE enhancements
 - Refinement of Proof of Status requirement to better leverage data already available at IDOH

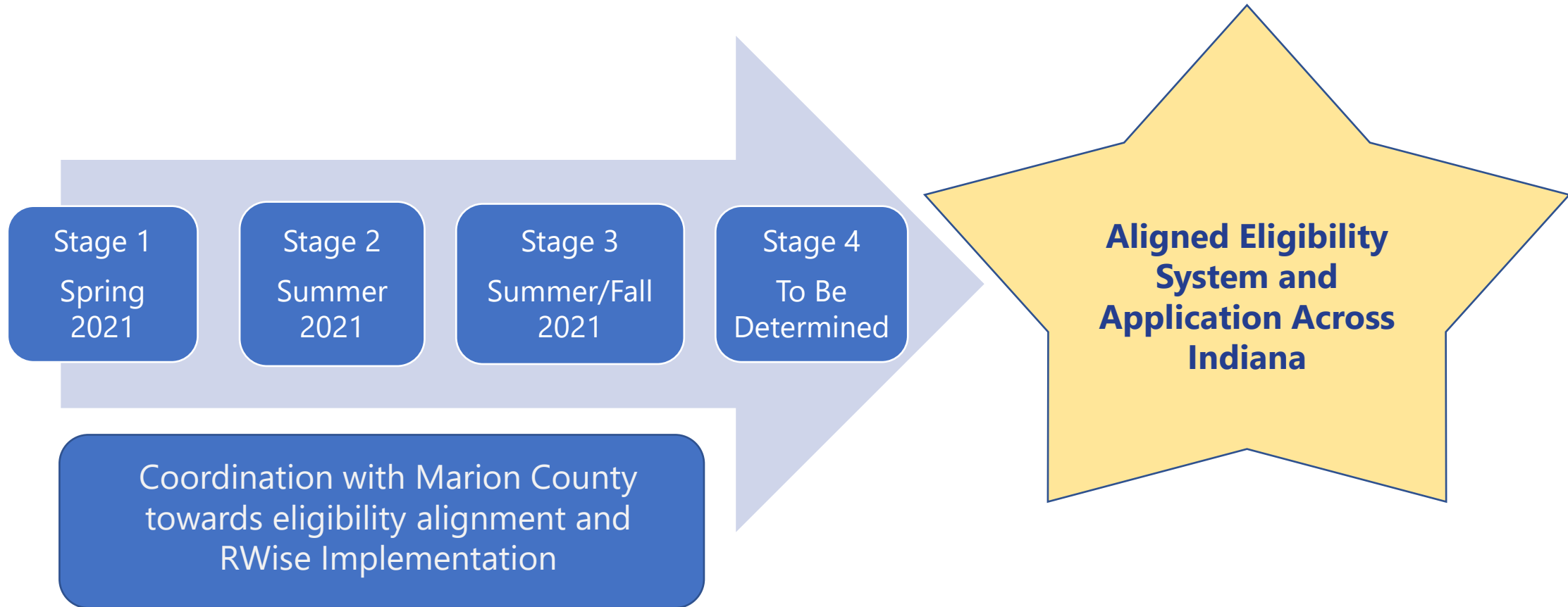


Eligibility Transition: Stage 3

- Birthday/Half-Birthday Recertification in alignment with Marion County Public Health Department
 - Transition is planned for summer/fall pending staffing and initial stage progress

Eligibility Transition

- RWisE is an eligibility system that Marion County utilizes that speaks directly to CAREWare

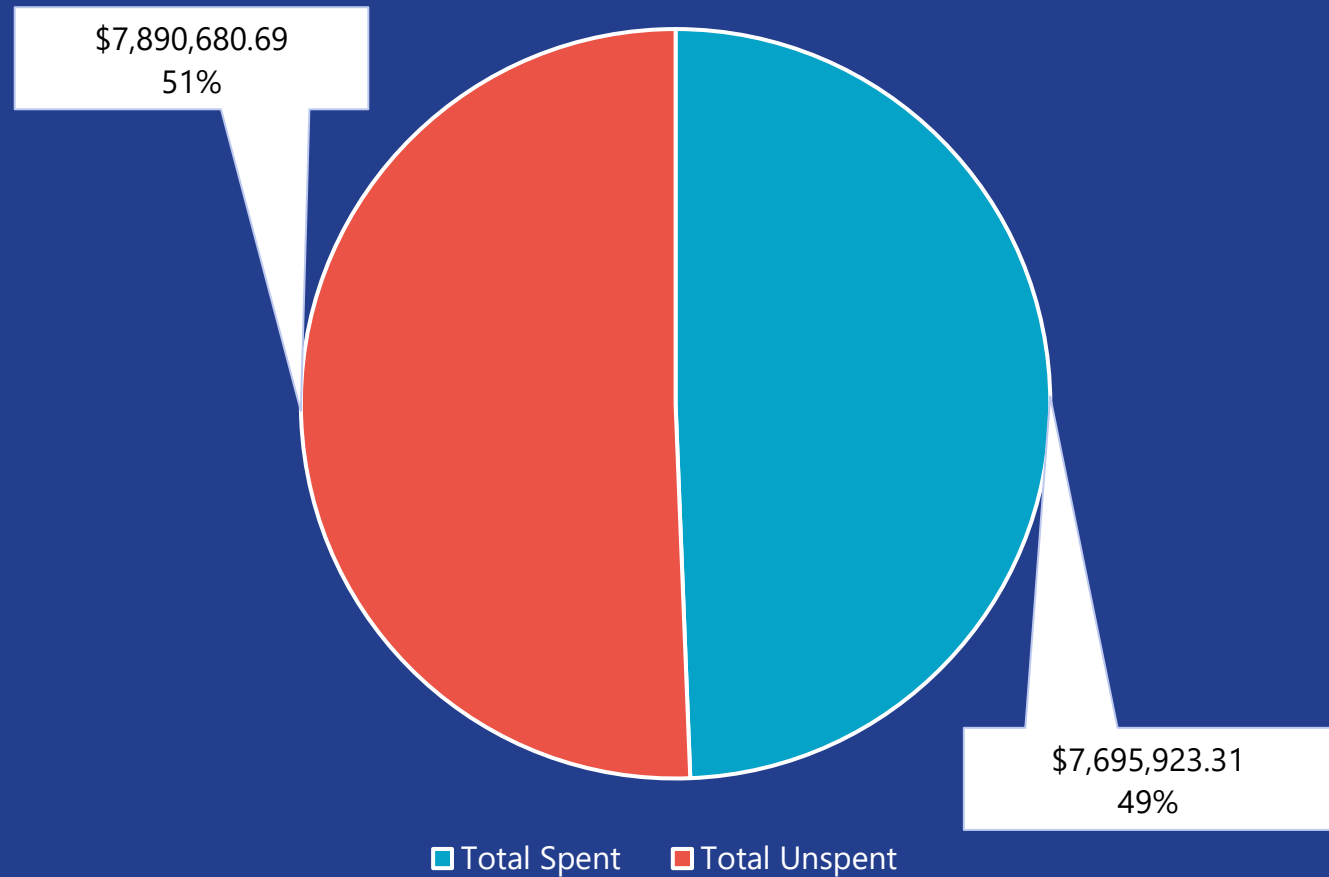

Cumulative Spending Updates

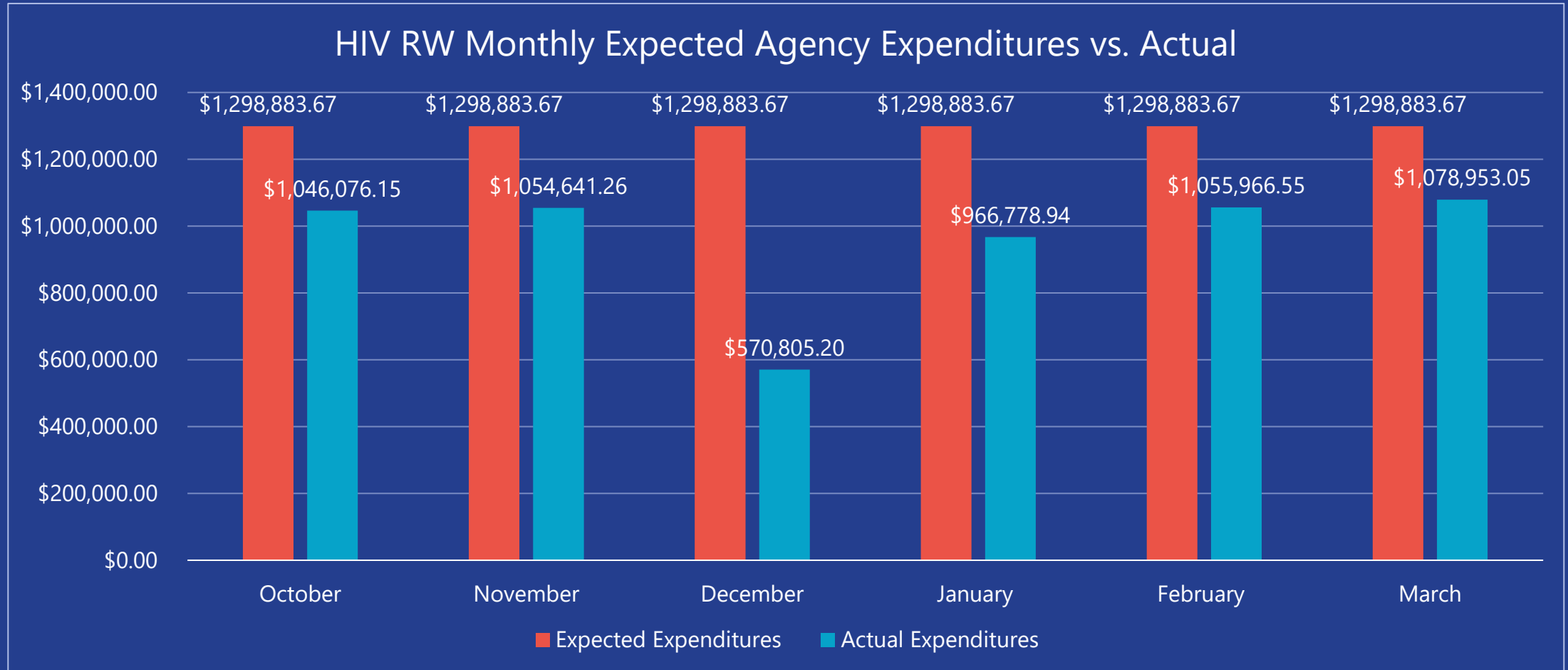
Total Contract Awarded

Invoice Submission

- Invoices are due to program by the 20th of month following month of services
- Please make sure the subject line of the email contains the correct naming format, this helps to ensure that it is being fast-tracked to payment.

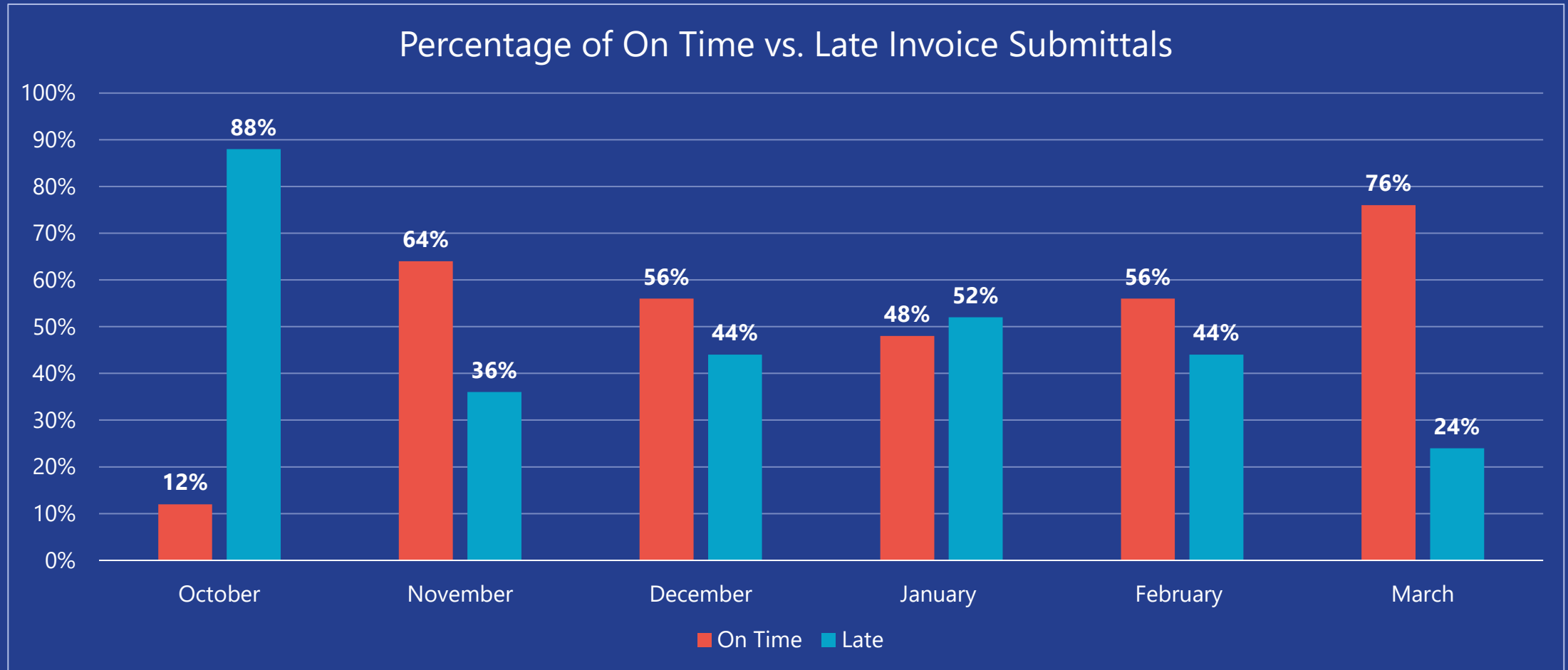

Common Invoice Issues

- Invoice is sent to the wrong inbox. Only use this mailbox:
 - HSPprogram@isdh.in.gov
- Incorrect Template Use
- Make certain that you use current invoice reflecting all recent RBCs or form updates
- There have been times when the PO has not had enough money left to pay the invoice submitted, this is an internal issue, and we are working with Finance to rectify these

What Can I do to increase my chances of getting paid in a timely manner?

Cumulative Spending Updates

Invoice Submission Check

1. Is the current date on the invoice?
2. Have I rechecked the expenses being claimed?
3. Have I rechecked my figures? Do my figures reconcile with receipts/bills/payroll?
4. Where am I sending the invoice to?
5. Do I have the Email Subject Line as clear as possible?

RBC/End of Contract and Future Awards

- Effective Budget Management
 - Why it is important to spend or return funds
- COVID 19 impacted agencies and spending in a variety of ways
 - We understand this but need your help with knowing what unspent funds you anticipate on current Ryan White contracts
- IDOH is requiring us to amend contracts that will return more than \$50,000
 - Amendments take approximately 2 months to process and have the risk of impacting 2021-2022 contract processing

RBC/End of Contract and Future Awards

IMPORTANT REMINDERS FOR SUBRECIPIENTS

1. Please closely and carefully assess your spending thus far on your RW-B contract and make an accurate projection of what you will have left **unspent** at the end of the contract
2. In these projections, please consider whether you have a need to move funds into other Service Categories in which you could better spend them

RBC/End of Contract and Future Awards

IMPORTANT REMINDERS FOR SUBRECIPIENTS

3. Once you have assessed your spending and made projections, including any considerations for moving money to different Service Categories, **IDOH is asking you to “return” via an RBC any projected unspent funds EXCEEDING \$50,000 by June 30th**

4. Please try to be accurate, but conservative, in your projections as to avoid “returning” too many funds and coming up short at the end of the contract – we will not be able to add funds at the end of your contract
