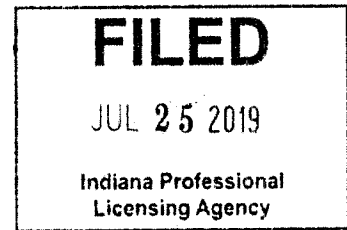

ORDER GRANTING VOLUNTARY SUMMARY SUSPENSION EXTENSION

An Administrative Hearing was held before an the Indiana State Board of Nursing (“Board”), on June 20, 2019, in the Auditorium of the Indiana State Government Center South, 302 West Washington Street, Indianapolis, Indiana46204, concerning the Petition for Summary Suspension filed against the Indiana nursing license of Jennifer L. Lewellyn, L.P.N. (“Respondent”).

The State of Indiana (“Petitioner”) was represented by Amanda Elizondo Cassidy, Deputy Attorney General. The Respondent did not appear, by person or by counsel, but she did provide an emailed statement for the Board’s consideration. In the email, Respondent stated she agreed to the summary suspension on her nursing license being extended for an additional ninety (90) days.

The Board, after reviewing Respondent’s statement at the June 20, 2019 meeting held in the Auditorium of the Indiana Government Center South, 302 West Washington Street, Indianapolis, Indiana 46204, grants Respondent’s Motion for a Voluntary Summary Suspension Extension.

WHEREFORE, RESPONDENT IS ORDERED to immediately cease all acts constituting the practice of nursing for a period of 90 days from the date of this Order.

IT IS FURTHER ORDERED that this Order shall serve as notice to all parties that this matter is reset on **SEPTEMBER 19, 2019**, for a hearing to occur at the Indiana Government Center South located at 302 West Washington Street, Indianapolis, Indiana 46204, at which the Board will consider whether the summary suspension of Respondent's license should be extended for an additional ninety (90) days.

SO ORDERED, this 25th day of July, 2019; this **Order is effective as of June 20, 2019.**
