**VOLUNTARY SUMMARY SUSPENSION ORDER**

The State of Indiana (“Petitioner”), by Roxanne M. Hilton, Deputy Attorney General, and Erica Weiss, L.P.N. (“Respondent”), and J. Clayton Miller, Counsel for Respondent agreed to a voluntary summary suspension, which summarily suspends the Respondent’s license for a period of ninety (90) days, and which Agreement has been submitted to the Board for approval.

The Board, after reviewing the Agreement at the January 17, 2019, meeting held in the auditorium of the Indiana Government Center South, 302 West Washington Street, Indianapolis, Indiana, now finds it has been entered into fairly and without fraud, duress, or undue influence, and is fair and equitable between the parties. The Board hereby incorporates the Agreement which is attached hereto and incorporated herein as **Exhibit A**.

The Board approved this Agreement by a vote of 5-0-0 and **SUMMARILY SUSPENDS** the license held by the Respondent for ninety (90) days.

**WHEREFORE, RESPONDENT IS ORDERED** to immediately cease all acts constituting the practice of nursing for a period of ninety (90) days, effective January 17, 2019.

Suspension Order is effective as of January 17, 2019.
