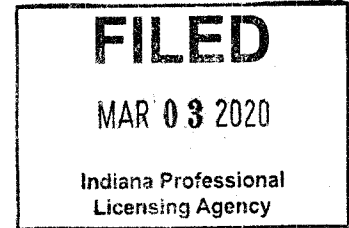

NOTICE OF PROPOSED DEFAULT

An Order to Show Cause hearing was scheduled to be held on February 27, 2020, in Room W064 of the Indiana Professional Licensing Agency, Indiana Government Center South, 302 West Washington Street, Indianapolis, Indiana 46204, concerning the Order to Show Cause filed by the Medical Licensing Board of Indiana (“Board”) against the license of Terrence D. Haffner, M.D., (“Respondent”).

The State of Indiana was represented by Melinda Pickett, Deputy Attorney General. Respondent failed to appear in person or by counsel.

Pursuant to Indiana Code § 4-21.5-3-24, the Board issues this Notice of Proposed Default on the following grounds:

1. Respondent’s address on file with the Indiana Professional Licensing Agency (“IPLA”) is 2435 Kingston Place, Ft. Wayne, Indiana 46815.
2. On August 30, 2019, the Board sent a notice to Respondent at his listed address and an additional address at the Allen County Jail located in Fort Wayne, Indiana informing Respondent of the date, time and place of the order to show cause hearing originally set for September 26, 2019.
3. On September 12, 2019, Respondent sent an email to Darren Covington, Board Director, indicating that he was released from jail in July 2019, received notice of the September 2019 hearing, and was unable to travel to the hearing due to being on house arrest. Respondent

requested a continuance until after January 12, 2020 as he expected to be released from house arrest by then.

4. On November 19, 2019, an Order of Continuance was issued by the board re-setting the Order to Show Cause hearing to February 27, 2020. The Order of Continuance was mailed to Respondent's address on file with the Board.

5. On February 27, 2020, Respondent failed to appear in person or by counsel for the conference.

6. Pursuant to Indiana Code § 4-21.5-3-20, Respondent was provided adequate notice of the Order to Show Cause hearing and failed to appear for said hearing.

ORDER

For Respondent's failure to appear for the scheduled Order to Show Cause hearing, the Board issues the following Notice of Proposed Default:

In accordance with Indiana Code §4-21.5-3-24, Respondent must file a written motion within seven (7) days of service of this Order requesting the Board not enter a default order in this case and stating the reasons relied upon for that request. Failure of the Respondent to file such a written motion within seven (7) days shall result in the issuance of a default order. If Respondent timely files a motion, the Board shall consider said motion along with any relevant facts in determining whether a default order should be entered. Should a default order be entered against Respondent, the Board may hold further proceedings it deems appropriate to complete this case without the participation of Respondent.
