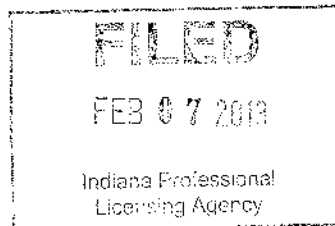

PETITION FOR SUMMARY SUSPENSION

The State of Indiana (“Petitioner”), by Counsel, Office of the Indiana Attorney General, by Deputy Attorney General Darren R. Covington, moves the Indiana Board of Pharmacy (“Board”) to summarily suspend the pharmacy technician license of Ashlynn Margaret Gildner, C.Ph.T. (“Respondent”) for ninety (90) days and in support of its petition states the following:

1. This Board has jurisdiction to suspend Respondent’s license in accordance with the provisions of Ind. Code ch. 4-21.5-4 and Ind. Code § 25-1-9-10.
2. Respondent’s address on file with the Indiana Professional Licensing Agency is 132 E. Marion Street, Mishawaka, Indiana 46545.
3. Respondent is a licensed pharmacy technician in the State of Indiana having been issued license number 67016432A on September 16, 2009.
4. At all times relevant herein, Respondent worked as a pharmacy technician at Meijer Pharmacy in Mishawaka, Indiana.
5. On or around October 21, 2012, Respondent signed three statements to Meijer loss prevention personnel that she had diverted Norco and Tussionex Cough Syrup, both controlled substances, for her own personal use.


6. Due to the above facts, Respondent represents a clear and immediate danger to the public health and safety if allowed to continue to practice as a pharmacy technician in Indiana.

WHEREFORE, the State of Indiana requests that this Board set a hearing on this Petition for Summary Suspension and suspend Respondent's license for a period of ninety (90) days and for all other proper relief.
