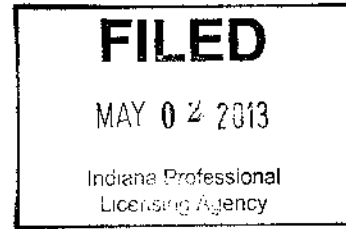


1. This notice is being provided to **Ashlynn Gildner** ("Respondent"), 132 East Marion Street, Mishawaka, Indiana 46545.
2. This notice is being provided to counsel for Petitioner, State of Indiana, Darren R. Covington, Deputy Attorney General, Office of the Attorney General, Indiana Government Center South, 302 West Washington Street, 5th Floor, Indianapolis, Indiana 46204, telephone number (317) 233-6506.
3. The official cause number of this action is: **2013 IBP 0011**.
4. This action is a hearing to determine whether the Board should extend the summary suspension of the Respondent's pharmacy technician certification.
5. A hearing regarding this matter will be held on **May 13, 2013, at 2:00 p.m.**, Local Time, in Conference Room W064 of the Indiana Professional Licensing Agency, Indiana Government Center South, 402 West Washington Street, Indianapolis, Indiana 46204.
6. The Board is empowered to hold this hearing pursuant to the authority of Ind. Code ch. 25-1-11 and Ind. Code art. 4-21.5.

7. The Board will be presiding as administrative law judge in this matter. 8. The hearing will address the issues contained in the summary suspension order filed by the State on February 22, 2013, which is attached hereto and incorporated herein by reference as Exhibit A.
9. Any party may be advised and represented by counsel at the party's own expense.
10. A party who fails to attend or participate in a pre-hearing conference, hearing, or other later stage of this proceeding may be held in default or have the proceeding dismissed under Ind. Code § 4-21.5-3-24.
11. Pursuant to Ind. Code § 4-21.5-3-34, this Board may afford parties the opportunity to informally settle matters; however, this section does not require any person to settle a matter under this agency's informal procedures.

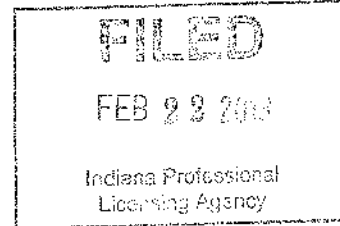

**SUMMARY SUSPENSION ORDER**

An administrative hearing was held on February 11, 2013, before the Indiana Board of Pharmacy (“Board”), in Room W064 of the Indiana Government Center South, 402 West Washington Street, Indianapolis, Indiana 46204, to consider the Petition for Summary Suspension (“Petition”) filed against Ashlynn Margaret Gildner, C.Ph.T. (“Respondent”), by the State of Indiana (“Petitioner”) on February 7, 2013.

The State of Indiana was represented by Darren R. Covington, Deputy Attorney General. Respondent failed to appear by person or by counsel.

The Board, pursuant to Ind. Code § 4-21.5-4-1 *et seq.* and Ind. Code § 25-1-9-10, by a vote of 6-0-0, **SUMMARILY SUSPENDS** the certification held by Respondent for ninety (90) days as the Board finds that an emergency exists and that Respondent represents a clear and immediate danger to the public health and safety if allowed to practice pharmacy in the State of Indiana.

This **NON-FINAL** emergency order is based on evidence supporting the following findings:

1. This Board has jurisdiction to suspend Respondent’s certification in accordance with the provisions of Ind. Code ch. 4-21.5-4 and Ind. Code § 25-1-9-10.

2. Respondent's address on file with the Indiana Professional Licensing Agency is 132 E. Marion Street, Mishawaka, Indiana 46545.

3. Respondent is a certified pharmacy technician in the State of Indiana having been issued certification number 67016432A on September 16, 2009.

4. At all times relevant herein, Respondent worked as a pharmacy technician at Meijer Pharmacy in Mishawaka, Indiana.


5. On or around October 21, 2012, Respondent signed three statements to Meijer loss prevention personnel that she had diverted Norco and Tussionex Cough Syrup, both controlled substances, for her own personal use.

**WHEREFORE, RESPONDENT IS ORDERED** to immediately cease all acts constituting the practice of pharmacy for a period of ninety (90) days, effective February 11, 2013.

**ORDERED**, this 22 day of February, 2013; **this Summary Suspension Order is effective as of February 11, 2013.**
