ORDER ACCEPTING AGREEMENT FOR SUMMARY SUSPENSION


The State of Indiana ("Petitioner"), by Deputy Attorney General Darren R. Covington, and Keith Michael Junker, R.Ph. ("Respondent"), by counsel, Shelley Jackson, signed an Agreement for Summary Suspension ("Agreement"), which was filed on August 13, 2012, whereby the Respondent's Indiana pharmacist license is summarily suspended indefinitely.

The Board, after reviewing the Agreement at the August 13, 2012 meeting, now finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Board by a vote of 7-0-0 approves and adopts in full the Agreement for Summary Suspension, attached hereto as Exhibit A.

WHEREFORE, RESPONDENT IS ORDERED to immediately cease and desist all acts constituting the practice of pharmacy.
