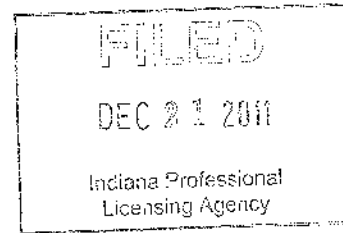

EXTENSION OF SUMMARY SUSPENSION ORDER

An administrative hearing was scheduled to be held on December 12, 2011 before the Indiana Board of Pharmacy ("Board") in Room W064 of the Indiana Government Center South, 402 West Washington Street, Indianapolis, Indiana 46204, to consider the Complaint ("Complaint") filed against Joyce Ellen Howard, C.Ph.T. ("Respondent") by the State of Indiana ("Petitioner") on October 24, 2011.

The Petitioner was represented by Darren R. Covington, Deputy Attorney General. Respondent did not appear in person or by counsel.

The Petitioner, at the request of the Respondent, by counsel, Michael R. Jeffries, moved the Board to continue the hearing in this matter until January 9, 2012. The Board, by a vote of 5-2-0, granted the Motion for Continuance.

The Board, pursuant to Ind. Code § 4-21.5-4-1 *et seq.* and Ind. Code § 25-1-9-10, by a vote of 7-0-0, extended the Summary Suspension of Respondent's license, which was set to expire on January 2, 2012, until January 9, 2012.

WHEREFORE, RESPONDENT IS ORDERED to continue to cease all acts constituting the practice of pharmacy through and until January 9, 2012.

ORDERED, this 21st day of December, 2011; this Summary Suspension

Order is effective as of December 12, 2011.
