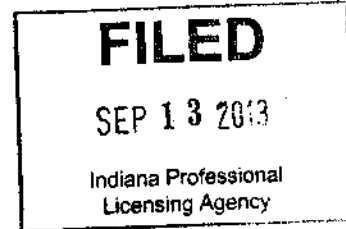

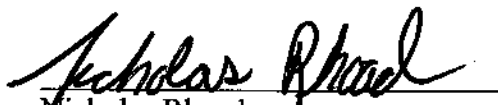
The Board, by a vote of 6-0-0, dismissed the Complaint.

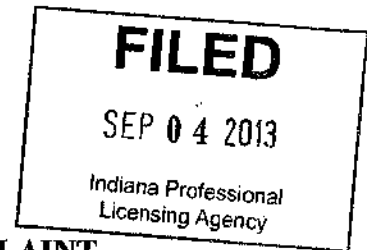

PETITIONER'S MOTION TO DISMISS COMPLAINT

Comes now the State of Indiana (Petitioner), by counsel, Office of the Attorney General, by Darren R. Covington, Deputy Attorney General, and respectfully moves the Indiana Board of Pharmacy (Board) to dismiss the Petitioner's Complaint filed against Vincent's Drug Store (Respondent) by the Petitioner on July 26, 2013, and in support thereof, states the following:

1. On July 26, 2013, the Petitioner filed a Complaint with the Board alleging that Respondent failed to provide information requested by the Board relating to its compounding practices and previous inspections.

2. Since the filing of the Complaint, Respondent has provided the requested information. This information has been reviewed by the Board's Compliance Committee, who has recommended dismissal of the Complaint.

3. Respondent attests that it did not received the Board's request for information.

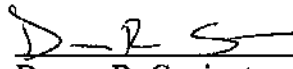
