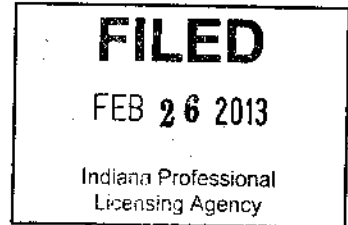

SUMMARY SUSPENSION ORDER

An administrative hearing was held on February 13, 2013, before the State Board of Dentistry ("Board"), in Room W064 of the Indiana Government Center South, 402 West Washington Street, Indianapolis, Indiana 46204, to consider the Petition for Summary Suspension ("Petition") filed against Kelly Marie Voss-Johnson, L.D.H. ("Respondent"), by the State of Indiana ("Petitioner") on February 12, 2013.

The State of Indiana was represented by Darren R. Covington, Deputy Attorney General. Respondent failed to appear by person or by counsel.

The Board, pursuant to Ind. Code § 4-21.5-4-1 *et seq.* and Ind. Code § 25-1-9-10, by a vote of 6-0-0, **SUMMARILY SUSPENDS** the license held by Respondent for ninety (90) days as the Board finds that an emergency exists and that Respondent represents a clear and immediate danger to the public health and safety if allowed to practice dental hygiene in the State of Indiana.

This **NON-FINAL** emergency order is based on evidence supporting the following findings:

1. This Board has jurisdiction to suspend Respondent's license in accordance with the provisions of Ind. Code ch. 4-21.5-4 and Ind. Code § 25-1-9-10.

2. Respondent's address on file with the Indiana Professional Licensing Agency is 5891 West Glenview Drive, McCordsville, Indiana 46055.

3. Respondent is a licensed dental hygienist in the State of Indiana having been issued license number 13005726A on June 24, 2005.

4. At all times relevant herein, Respondent worked as a dental hygienist at Beautiful Smiles for David W. Goris, D.D.S.

5. On or around January 29, 2013, Respondent was charged in Marion County, Indiana Superior Court with Forgery, a Class C Felony, under Cause Number 49G20-1301-FC-006400, after Respondent stole Dr. Goris' prescription pad and fraudulently wrote prescriptions for Vicodin ES for herself.

WHEREFORE, RESPONDENT IS ORDERED to immediately cease all acts constituting the practice of dental hygiene for a period of ninety (90) days, effective February 13, 2013.

ORDERED, this 26 day of February, 2013; this Summary Suspension Order is effective as of February 13, 2013.


