# Section 1 – Background

### 1.1 Request for Qualifications

The Indiana Arts Commission ("IAC" or "Commission") solicits Statements of Qualification for the Award Design and Production of the 2023 Indiana Governor's Arts Awards (the "Project"). A submittal of a Statement of Qualification does not guarantee that the Artist or Creative Team will be contracted to perform any services but only serves as a notice to the Indiana Arts Commission ("IAC" or "Commission") that the Artist or Creative Team desires to be considered.

#### 1.2 Indiana Governor's Arts Awards

Arts and creativity strengthen Indiana's people and places.

To recognize outstanding achievements and contributions to arts and creativity in Indiana, the Office of the Governor with the Indiana Arts Commission presents the **Governor's Awards for the Arts**, the highest honor the state gives in the arts.

These awards honor those who maximize their roles as innovators, supporters, and advocates to grow arts and creativity on the state or national level.

The IAC coordinates the presentation of the Governor's Arts Awards. The Commission solicits nominations for award recipients and coordinates the selection process, and the awards are presented by the Governor and First Lady of Indiana. The IAC commissions an Indiana artist to create custom works of art to serve as the awards.

# <u>Section 2 – Request for Qualifications</u>

### 2.1 Scope of Services

The Indiana Arts Commission is seeking Statements of Qualifications from Artists or Creative Team for the Award Design and Production Services for the 2023 Governor's Arts Award. The Indiana Arts Commission and the Office of the Governor retain exclusive and sole discretion for making the selection.

### 2.2 Specifics

Seven (7) awards will be created. No restrictions on content, medium, or style, but each piece must reflect the purpose of the Governor's Arts Awards to recognize outstanding achievement and contributions to arts and creativity in Indiana. The seven

# **Section 3 – Procurement Process**

### 3.1 Selection Process and Criteria

A selection committee comprised of representatives from the Office of the Governor and the Indiana Arts Commission will review and evaluate submissions based on the following criteria:

- Artistic excellence;
- Appropriateness and quality of artist's medium, style, and previous work as they relate to the goals of the Governor's Arts Awards;
- Experience with projects of a similar scale and scope;
- Ability to work within the specified project timeline; and
- Appropriateness of the budget

### 3.2 Project Budget

The total allowable budget for the Project is not to exceed **Seven Thousand Dollars** (\$7,000.00) and is inclusive of all costs associated with Artist or Creative Team

This opportunity is open to artists currently residing in Indiana and 18 years old or older. Artists must go through a mandatory clearance check to ensure they are in good standing with the State of Indiana.

# 4.1 RFQ Responses

Interested Artists or Creative Team must submit their proposals via the <u>submission form</u> (accessible via QR Code) to be considered for this Request for Qualifications.

The proposal shall include the following:

- Letter of Interest & Artist Statement: Provide a letter of interest and an artist statement including availability to participate within the provided timeline and relevant details that make the Artist or Creative Team a good candidate for the project.
- **Work Samples:** Upload up to 10 images of original, complete artworks which demonstrate qualifications for the project. Include the title, medium, dimensions, project budget, year completed, and a description.
- **Additional Information:** Links or websites that provide examples of previous experience are welcome, but not required.
- **Total Proposed Budget:** Detail proposed expenses, including a brief expense description and the numeric dollar amount associated with each expense.

Note: Artists are welcome to submit ideas for the awards but are not required to submit mockups or designs as a part of the request for qualifications.

### **4.2 Deadline for Submittal of Responses**

<u>Thursday, May 4, 2023 at 11:59 PM EDT</u> – Pursuant to Section 4.1, Artists or Creative Team must submit their proposals via the <u>submission form</u>.

Proposals that are: submitted via other channels of communication; late; incomplete, and/or ineligible **will not be accepted.** 

# 4.3 Notifications and Proposals

Notifications will be issued no later than June 2023. Selected artist(s) will be required to attend a virtual meeting to discuss the development of a final proposal for award design. The final design must be approved by the selection committee.
