# **Program Overview**

What is Vision & Venture: Vision & Venture focuses on foundational business processes and compliance knowledge for creatives with less than one year of business experience. The program aims to place artists at the center of business strategy discussions, ensuring that strategy and marketing consideration are integral from the beginning stages of transforming creative ideas into viable businesses. Vision & Venture consists of a six-week virtual series focused on essential start-up tasks. Dr. Elaine Grogan Luttrull of Minerva Financial Arts will lead interactive workshops designed for a cohort of no more than 15 creatives.

**Who Can Apply:** Indiana artists from a variety of disciplines interested in pursuing creative entrepreneurship.

## **Program Details**

#### **Program Goal**

The program serves emerging artists of multiple disciplines as a mechanism to inject business strategy and compliance into a creative business at the onset of its formation. The six-week series focuses on required startup tasks. The program serves as a precursor to the On-Ramp Creative Entrepreneur Accelerator.

- Meet needs assessed of artists including marketing and financial support and education
- Build knowledge, capacity, skills, and networks that increase markets and audiences for Indiana's creative sector.§

#### **Honorarium Payment**

Creatives who are accepted into the cohort and complete all workshops will receive an honorarium of \$1,500.

This is not a prescriptive grant, but an honorarium for creative entrepreneurs to put toward start up costs that have been identified during the series to accompany their new business plans.

Participating creative entrepreneurs will receive the full \$1,500 payment at the conclusion of all workshops.

### **Eligibility**

#### Eligible Applicants\*

- Artists and creatives in any artistic discipline that include the following;
  - Dance
  - Music
  - Opera/Music Theatre
  - Theatre
  - Design Arts
  - Visual Arts
  - Photography
  - Media Arts
  - Literature
  - Crafts
  - Folk/Traditional Arts
  - Interdisciplinary Arts
  - Multidisciplinary Arts
- Less than one year of business experience
- Currently an Indiana resident
- 18 years or older

\*IAC staff may follow up to request documentation or additional information and will make the final determination on eligibility.

#### **Additional Eligibility Requirements:**

 Attendance confirmation: Applicants must confirm that they are able to attend all scheduled workshop sessions with no prior schedule conflicts to be considered for cohort selection.

#### **Evaluation Criteria and Review Process**

#### **Evaluation Criteria**

Applications will be evaluated by how well they meet the following criteria:

- **Artist Overview (50%)** The extent to which the artist articulates their unique artistic perspective and background as well as demonstrates an aligned fit for the program.
- **Vision What and Who? (30%) –** The extent to which the artist can articulate their creative business vision by briefly describing their potential business offerings, collaborators and intended audience.
- **Venture Why? (20%) –** The extent to which the artist can explain the immediate creative economy's need for their potential business offerings and the business value proposition.
