#### **MINUTES**

#### ALCOHOL AND TOBACCO COMMISSION

#### **DECEMBER 17, 2024**

#### CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

#### DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the December 3, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

#### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Fifty-one dispositions were submitted with fines totaling \$36,950.00. Commissioner Jones seconded. The motion was unanimously approved.

#### HEARING JUDGE'S RECOMMENDATIONS

TC17284001 SMOKEVILLE 2, LLC – Vice Chairman Payne, who sat as hearing judge, stated this tobacco certificate was set for a Revocation Hearing, due to the fact that the location of the business is less than 1000 feet from a school. The application was filled out correctly, but the certificate was issued in error. The holder appeared at the hearing, questioned the measurement and talked about possibly changing the business to a convenience store instead of a smoke shop. Objections were also filed by the holder, after the issuance of the proposed findings of fact and conclusions of law by Hearing Judge Payne. Those objections provided no proof of any change in business operations, just a change in the signage. The Hearing Judge submitted Proposed Findings of Fact and Conclusions of Law for recommendation to the Commission.

Vice Chairman Payne moved to revoke the tobacco certificate. Commissioner Jones seconded. The motion was unanimously approved.

#### CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which

have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

#### WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

#### ITEMS FOR DISCUSSION

<u>DL67-33907 DOLGENCORP LLC</u> – Chair Allen noted this was continued from the December 3<sup>rd</sup> meeting. It is a new application with the local board voting 3-0 to approve. Due to Dollar General having been denied a permit in the last year, there was a question as to how the law regarding special disqualifications would affect the new permit application. The matter was reviewed by legal and was noted that the denial was based on 905 IAC 1-27-4, which is a rule that looks at the geographical location of the business and not the character of the applicant. The community where the permit was denied loves Dollar General without an alcohol permit.

Chair Allen moved to uphold the local board's recommendation to approve the new permit. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-37227 SALTY LEMON INC.</u> – Chair Allen noted this is a renewal with the local board voting 2-1 to deny.

Commissioner Maginn stated the owner of this business has numerous gas stations and this is his only operational restaurant permit. There have been numerous problems at the establishment that included nudity, public nuisance, and gun incident involving the security staff. Violations have also occurred at the gas station locations.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR02-41819 RBNL CARIBBEAN & TAKEOUT LLC</u> – Chair Allen noted this is a new application with the local board voting 3-0 to deny.

Commissioner Maginn stated this is a new application and the local board looked at a current business by the same permit holder as an example of this applicant's business operations. The other location has had 42 police runs and violations that included selling misbranded products, drugs, unstamped/nontaxed cigarettes and an unregistered pesticide.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR08-38287 WAY TO GO MOTORS LLC</u> – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated the local board had concerns about ownership and sales. The corporation was dissolved in 2023. Excise has sent emails, but no response has been received.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR12-35922 MI HACIENDA RESTAURANT AND BAR, INC.</u> – Chair Allen noted that this is a renewal with the local board voting 3-1 to deny.

Commissioner Maginn stated this permittee had violations that included retail to retail sales, an undisclosed felony, falsification of records and most egregious was the owner not only served a 17-year-old minor but was the person pouring the alcohol into her mouth.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Vice Chairman Payne seconded.

Commissioner Jones stated there were actually two undisclosed felonies and a misdemeanor for invasion of privacy related on the same case.

The motion was unanimously approved to deny renewal.

<u>RR21-41866 DIAMOND EVENT CENTER LLC</u> – Chair Allen noted this is a request for catering hall designation.

Commissioner Maginn moved to approve the request for a catering hall designation. Vice Chairman Payne seconded. Commissioner Jones asked the approval to be conditional upon the 210 permit being approved. Commissioner Maginn amended motion to include approval of 210 permit. Motion was unanimously approved.

RR84-40209 NEW GOSHEN PUB INC. AND RR84-41877 AMBER & JASON'S NEW GOSHEN PUB LLC – Chair Allen noted this matter was continued from the November 19<sup>th</sup> meeting. The corporation of New Goshen Pub Inc. is dissolved, and one of the 50% shareholders is deceased. The new LLC is not part of the old corporation. Upon completion of the new application and the issuance of the permit, New Goshen Pub Inc. will surrender its permit.

Commissioner Maginn moved to recognize the corporation will relinquish the permit and uphold the local board's recommendation to approve the new LLC permit.

Commissioner Jones noted that the local board scheduled the new LLC permit for the January 7, 2025 Commission agenda because it is standard practice for the local board to schedule one commission out if the next Commission meeting is the day after the local board hearing.

Chair Allen asked for consent by the commissioners to add the new application to the agenda. Consent was unanimously given. The Chair stated that it is out of the ordinary to do this, but it moves us faster away from Amber & Jason working on a dissolved corporation's permit, puts the liability protection in place and gets a business properly operating.

Commissioner Maginn moved to approve the new permit. Vice Chairman Payne seconded.

Vice Chairman Payne asked if the business was open and Chair Allen stated it was, but Amber & Jason are operating on a Manager's Questionnaire from New Goshen Pub, a dissolved corporation.

The motion to approve the new permit was unanimously approved.

<u>RR51-31167 JP ENDEAVORS LLC</u> – Chair Allen stated this is a request for reinstatement. The permit was revoked because of an incomplete application.

Deputy Director Serak noted the application is now complete.

Chair Allen moved to reinstate the permit and allow the renewal to continue. Commissioner Maginn seconded. The motion was unanimously approved.

RR02-07083 CONZIE INC. – Chair Allen noted this comes on for an extension request.

Commissioner Maginn stated there is an ownership issue and one of the owners is deceased. Also, the corporation was dissolved 20 years ago. The business was sold on contract, but a transfer was never filed. For the last few years, someone has been falsely signing the renewals for the deceased owner. The problems with the corporation are in the process of being worked out.

Commissioner Maginn moved to approve the extension request while the problem with the corporation is being worked out with the Secretary of State. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen voted to approve with the caveat she in no way considers Conzie, Inc. a valid corporation and the operation of this permit is at their own risk. Also, signing documents for someone who is deceased is forgery and could be a felony if caught. She noted the best path forward is to proceed with the transfer.

<u>RR71-39144 COOL RUNNINGS RESTAURANT AND BAR NO 2, LLC</u> – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated this permittee had a problem with insurance and also had two violations in the last year that have been settled.

Commissioner Maginn moved to approve the extension while the renewal is being processed. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-09422 SKYLINE CLUB LLC - Chair Allen noted this comes on for an extension request.

Commissioner Maginn stated this has been on the agenda several times for extensions due to ownership issues. A three-week extension was granted in November. Ownership documents have been submitted and the renewals can proceed.

Commissioner Maginn moved to approve a 90-day extension, minus the three weeks already used. Vice Chairman Payne seconded. The motion was unanimously approved.

RH53-30229 HHM MGMT SUB LLC - Chair Allen noted this is on for an extension request.

Commissioner Maginn stated this permittee has a problem with ownership disclosure. This request is for a second extension while they are working on those disclosures.

Commissioner Maginn moved to approve the extension request. Commissioner Jones seconded. Chair Allen voted to approve. Vice Chairman Payne voted no and stated he does not understand how ownership is not known and wonders how they file taxes. The motion was approved 3-1.

<u>RR49-32157 REGAL CINEMAS INC.</u> – Chair Allen noted this is on for an extension request. The Commission received documents stating this business is in bankruptcy. She feels it could possibly be renewed but would rather approve an extension.

Chair Allen moved to approve the extension request. Commissioner Maginn seconded. The motion was unanimously approved.

MD49-00005 G-RIOS INC. – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated the business had a violation this year that was settled, and they are working through the renewal process.

Commissioner Maginn moved to approve the extension request. Vice Chairman Payne seconded.

Commissioner Jones noted the permit expired in November and questioned whether the business was operating. The answer was not known.

The motion passed 4-0.

RR28-40486 THE VAULT BAR LLC – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated the Commission had a technical error in processing the renewals.

Commissioner Maginn moved to approve a fee-waived extension. Commissioner Jones seconded. The motion was unanimously approved.

#### **INACTIVE FILES**

Chair Allen asked the commissioners to approve by consent the removal of one permit from the list. Consent was approved.

Commissioner Maginn moved to make the 6 permits dead previously posted on the December 3, 2024 meeting agenda. Vice Chairman Payne seconded. The motion was unanimously approved.

Chair Allen stated there are 18 permits being announced today to be made dead at the January 7, 2025 meeting.

<u>3<sup>RD</sup> PARTY ONLINE PROGRAM APPROVAL – SERVING ALCOHOL, INC./SERVINGALCOHOL.COM</u> – Chair Allen stated Sgt. Heather Lynch submitted a 3<sup>rd</sup> party online server training program to the Commission for approval. Sgt. Lynch recommended approval after reviewing, auditing and comparing it to our program requirements.

Commissioner Maginn commented that Sgt. Lynch was very thorough in making sure this program is in compliance with Indiana law and identified updates that were needed.

Commissioner Jones also commended Sgt. Lynch on an excellent job.

Commissioner Maginn moved to approve the new program. Commissioner Jones seconded. The motion was unanimously approved.

#### POLICY DETERMINATIONS

NON-RULE POLICY #24 REVISION – Chair Allen noted the Commission is proposing amendments to Non-Rule Policy #24, which deals with receiving complete or incomplete applications. It will be posted on the ATC website. The Commission will consider the revisions at the January 22, 2025 meeting.
