#### **MINUTES**

#### ALCOHOL AND TOBACCO COMMISSION

#### **DECEMBER 3, 2024**

#### CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

#### **DISPOSITION OF MINUTES**

Vice Chairman Payne moved to approve the minutes from the November 19, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

#### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Forty-seven dispositions were submitted with fines totaling \$29,950.00. Commissioner Maginn seconded. The motion was unanimously approved.

#### HEARING JUDGE'S RECOMMENDATIONS

<u>DL54-40445 RJIMENEZ LLC</u> – Vice Chairman Payne, who sat as hearing judge, stated this application was denied by the local board and upheld by the Commission. An appeal was filed and the matter was set for hearing. There were questions regarding ownership and business practices. The Hearing Judge submitted Proposed Findings of Fact and Conclusions of Law for recommendation to the Commission.

Vice Chairman Payne moved to uphold the denial. Commissioner Jones seconded. The motion was unanimously approved.

<u>CH49-30164 PLUSH PARTIES & EVENTS LLC</u> – Commissioner Maginn stated this permittee has a pending violation. A Show Cause hearing was scheduled because there has been no contact with the permittee regarding the violation. The permittee failed to appear at the hearing. The Hearing Judge recommended revocation of the permit.

Commissioner Maginn moved to uphold the recommendation to revoke the permit. Vice Chairman Payne seconded. The motion was unanimously approved.

RR32-38871, RR29-38747, RR29-38748, RR79-38749, RR06-38752, RR29-38865 WATSON HOLDINGS INC. – Chair Allen noted these come on the agenda for a Motion and Request for Permission to Transfer Permits.

Commissioner Maginn stated all of the permits were denied by the local board and appeals were filed. The permittee is also requesting the ability to file transfers. There are buyers for four of the permits at this time.

Commissioner Maginn moved to allow a strict 90-day period for transfer applications to be filed on all six permits. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>CONDITIONAL APPROVAL DENIALS</u> - Chair Allen asked the Commission, by consent, to add the following three applications to the agenda that were previously denied due to missing items not being submitted. Consent was granted.

<u>RR02-35425 WHAT'S UP PUB & GRUB INC</u> – Chair Allen noted all missing items were submitted and the permit is ready to be issued.

Chair Allen moved to reverse the denial and to issue the permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR70-00852 BPO ELKS 1307</u> - Chair Allen noted all missing items were submitted and the permit is ready to be issued.

Chair Allen moved to reverse the denial and to issue the permit. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR02-30794 MATHEWS FORD</u> - Chair Allen noted this permittee submitted a certificate of insurance, however, the insurance d/b/a is a different LLC than what is on file with the Commission.

Chair Allen moved to reinstate the permit and issue extensions, if needed, while the matter of the insurance is being settled. Commissioner Jones seconded. The motion was unanimously approved.

#### CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

#### WAIVERS OF FEES - LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

#### ITEMS FOR DISCUSSION

<u>RR20-41451 MITZY CALLEJA-CASTILLO</u> – Chair Allen noted this is a new application with the local board voting 3-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL67-33907 DOLGENCORP LLC</u> – Chair Allen noted this is a new application with the local board voting 3-0 to approve. However, Dollar General was denied a permit in the last year, so there is a question as to the law regarding special disqualifications and how it may have been interpreted in the past as far as this permittee being granted a new permit.

Chair Allen moved to continue this until the December 17<sup>th</sup> meeting. Commissioner Maginn seconded. The motion was unanimously approved.

<u>RR71-35240 THE GARAGE ARCADE BAR LLC</u> – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated the permittee has a pending violation that is in the process of being settled with Prosecutor Wignall. The current extension expires on December 6<sup>th</sup>.

Commissioner Maginn moved to approve a 90-day extension. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR25-87230 NARCISCO SANCHEZ</u> – Chair Allen noted this is on for an extension request. Consent was given to add this to the agenda.

Commissioner Maginn stated the permittee is in the process of submitting a corrected certificate of insurance and a Manager's Questionnaire. The most recent extension expired on November 17<sup>th</sup>.

Commissioner Maginn moved to approve a 90-day extension. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>CONDITIONAL APPROVALS</u> – Chair Allen stated while trying to solve the problem of incomplete applications being submitted and not addressed, caused by the alcohol industry, a bigger burden has been put on the Commission. Permits on the current list with holds need to be addressed quickly and sufficiently in a way that does not take an excessive amount of Commission time. The solution to this problem is the filing of complete applications initially. The Commission is going to reevaluate the non-rule policies on conditional approvals and submitting complete applications. There are still permittees a year past expiration that have not addressed the holds but continue to serve. Those will be addressed as

the Commission finds them and the permittees may be brought in for revocation hearings. If the holds are not addressed and extensions are not issued, there is no authority to operate.

Commissioner Maginn stated the Chair has put in an incredible amount of time and effort trying to work with the permittees on this issue, but the industry needs to step up and get the paperwork submitted. There is probably going to be a very strict policy on the front end where only completed applications are accepted because the conditional approval policy is not being followed.

Chair Allen commented that she now appreciates the work the processors do every day trying to process applications that are complete, while others are being submitted one piece at a time.

Commissioner Maginn stated the Commission should not have to beg for the missing paperwork, after allowing 30 days to submit paperwork for their permit. It is not acceptable.

Vice Chairman Payne noted the majority of permittees who submit completed applications should be commended for their efforts.

Chair Allen pointed out that compliant applicants are being harmed in the process because the processors are having to spend so much time on the incomplete applications that it interferes with the time spent on those applications submitted correctly. There will be more to come on this.

#### **INACTIVE FILES**

Commissioner Maginn moved to make the 10 permits dead previously posted on the November 19, 2024 meeting agenda. Vice Chairman Payne seconded. The motion was unanimously approved.

Chair Allen stated there are 7 permits being announced today to be made dead at the December 17, 2024 meeting.

## Noteworthy Violation for 12/3/24 Commission Meeting

RC4906285: Indy Trade Association Inc. (DBA: Indy Trade Association) in Indianapolis, Marion County. On September 9, 2024, the Marion County Task Force initiated a permit visit at the business as a result of a homicide that took place in a connected parking lot. Once at the business, officers found open alcoholic beverages containers, plant material that tested positive for marijuana, incomplete employee permit records, and a patio that had not been approved. Officers were unable to tie the business to the recent violence, however they did write numerous violations for public nuisance (drugs), failure to remove containers after closing, and sale of alcoholic beverages to non-club members. The parties have agreed to a \$1,500 civil penalty.
