**PROPOSED FINDINGS OF FACT
AND
CONCLUSIONS OF LAW**

**I.
BACKGROUND OF THE CASE**

The Permittee, Tiffany Logan, Permit Number BR1599847 (“Permittee”) is the Permittee for the renewal of an Alcohol and Tobacco Commission (“ATC”) employee permit. The Permittee filed her request for employee permit renewal, upon review of Permittee’s record with the Indiana Bureau of Motor Vehicles, ATC staff determined that Permittee had two (2) unrelated convictions for operating while intoxicated as defined by IC 7.1-1-3-13.5. The date of the convictions are as follows: (1) Conviction from Marion Superior Court 26, under cause number 49D26-2105-F6-013738, decided March 10, 2022, Operating a Vehicle While Intoxicated; and (2) Conviction from Franklin City Court, under cause number 41H01-1907-CM-000568, decided August 19, 2019, Operating a Vehicle While Intoxicated. Permittee appealed the denial of her alcohol permit renewal and the matter was set for a hearing on January 7, 2025.


**II.
EVIDENCE BEFORE THE ATC**

1. Applicant failed to appear for the requested appeal hearing on January 7, 2025.

3. Twenty dollars (\$20) of the application fee shall be refunded according to IC 7.1-3-19-12. Twenty-five dollars (\$25) of the permit fee shall be disposed of pursuant to Title 7.1, Article 4 of the Indiana Code.
4. Any conclusion of law may be considered a finding of fact if the context so warrants.

THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that the denial of the permit renewal BR1599847 is in compliance with the law. The eligibility date for denied Permittee to reapply for an employee permit is March 10, 2025, and twenty dollars (\$20) of the application fee shall be returned to Tiffany Logan.
