ALCOHOL AND TOBACCO COMMISSION

MARCH 5, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, General Counsel Merritt, Deputy Director Serak, and Prosecutor Wignall were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the February 20, 2024 meeting. Commissioner Maginn seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Fifty-six dispositions were submitted with fines totaling \$32,450.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine sellers applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

RR55-36667 BRL PROPERTIES LLC – Chair Allen noted this is a renewal application with the local board voting 2-2.

Commissioner Maginn stated the business has violations for falsification of the application. The owners of this permit have undisclosed convictions. There was no discussion by the local board regarding any issues with the running of the business.

Commissioner Maginn moved to approve a one-year approval. Vice Chairman Payne seconded but explained that in the future he may not vote to approve. The documents submitted to us by the applicants need to be accurate no matter who is filling out the application.

Chair Allen agreed with the Vice Chairman regarding the submission of the documents. The applicant is signing under the penalties for perjury, no matter who filled out the paperwork. She also may start voting to deny these applications.

Commissioner Jones voted no to the one-year approval based on the fact that the manager stated he did not read the application carefully and was quick to throw the preparer under the bus for the error and did not take responsibility. The Commissioner also stated his concern about how the owner handled the DUIs by falsely stating someone else was the driver, showing a lack of credibility.

The approval for a one-year renewal passed by a vote of 3-1.

RR84-01881 GREG A WILSON – Chair Allen noted this is a renewal application with the local board voting 4-0 to deny.

Commissioner Maginn stated this permittee has been cited for retail to retail. Multiple receipts were found in the business for purchases of alcohol from a business that is not a wholesaler.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

RR84-40872 AND RR84-40873 WTH CLUB KOYOTE LLC – Chair Allen noted these are new applications with the local board voting 4-0 to deny.

Chair Allen stated the attorney representing this permittee sent a request for continuance so the Commission can review the record regarding these applicants more closely and also answer questions the local board vote has brought up.

Chair Allen moved to continue this until April 2, 2024, and to send the questions to the commission's legal staff for recommendation. Commissioner Jones seconded. The motion was unanimously approved.

RR79-34150 CAPITAL CONNECTION LLC AND RR79-31044 THREE O EIGHT LLC – Chair Allen noted these renewals were both remanded due to questions as to whether the local board was consistent with their voting based on similar problems with the permittees. Both permittees had similar violations, however, one was a 4-0 denial and the other was a 2-2 vote.

Capital Connection LLC was again denied 4-0 by the local board. The business has changed some policies regarding the violations that have been a problem. They were not previously on the PACE Program.

Three O Eight LLC was a 2-2 vote by the local board. The business was previously put on the PACE Program, but was cited for violations despite that. The business has a new manager and has changed some of their policies regarding these violations.

Commissioner Maginn moved to approve one-year renewals and for both to be on the PACE Program for that year. Vice Chairman Payne seconded, but reminding the permittees that any new violations will be problematic in the future.

Commissioner Jones voted no. He stated the food sales figures submitted for Capital Connection were exactly the same for the last four renewals. He feels that goes to credibility. Regarding Three O Eight, he felt the local board was correct in their comments against renewal.

The Commission voted 3-1 to approve a one-year renewal and for both permits to be placed on PACE for that year.

RR49-11398 TRI ENTERTAINMENT CORPORATION – Chair Allen noted this is a request for extension. The permittee recently settled a pending violation, paid what was owed to wholesalers and is no longer on the no-ship list. There is one additional pending violation that is scheduled for a prehearing conference on March 25, 2024.

Commissioner Maginn moved to approve the 90-day extension request, pursuant to submission of a corrective action plan. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones stated he was leaning towards voting, no, based on credibility of the permittee. He expects the permittee to adhere strictly to the policies that will be listed on the corrective action plan.

RR49-18714 AND RR02-34452 P.F. CHANG'S CHINA BISTRO INC. AND RR49-34258 CONDADO TACOS 6, LLC AND RR49-35258 CONDADO TACOS 10, LLC. – Chair Allen noted extension requests have been filed for these permits.

Commissioner Maginn stated there are ownership issues with these permits that are in the process of being worked out.

Commissioner Maginn moved to approve 90-day extensions for these permits. Vice Chairman Payne seconded. The motion was unanimously approved.

RR4933683 MPAG LLC – Chair Allen noted this is a request for extension continued from the last meeting. It appears the issues have been corrected.

Commissioner Maginn moved to approve the remainder of the 90 days left on the extension. The motion was unanimously approved.

RR49-03006 DEER-BELL, INC. – Chair Allen noted this is a request for extension with violations pending. The permittee submitted a corrective action plan.

Commissioner Maginn noted the extensive corrective action plan states the issues regarding the violations are addressed and hopefully are taken care of at this point.

Commissioner Maginn moved to approve the extension request. Commissioner Jones seconded. The motion was unanimously approved.

RR79-31044 THREE O EIGHT LLC – Chair Allen added this extension request by consent of the Commission. The renewal was just approved.

Commissioner Maginn moved to approve the extension request. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones approved the extension, even though he voted to deny the renewal.

Noteworthy Violations for 3/5/24 Commission Meeting

RR4928625: MOH, Inc. (DBA: The Zone Bar) in Indianapolis, Marion County. In May 2023, the Marion County Task Force received a complaint from IMPD that it was a problem location and that narcotics were being used inside the business. IMPD led several undercover operations during the summer of 2023 and confirmed the use of narcotics inside the business during operating hours. Violations were written for public nuisance, lack of employee permits, allowing a minor to loiter and more. **The parties have agreed to a \$2,000 civil penalty and a 3-day weekend suspension of the alcohol permit. The business is also being placed on the PACE program.**

TC15297001: Vigo Market LLC. (DBA: Food Mart) in Terre Haute, Vigo County. On December 21, 2023, District 5 Officers conducted a tobacco compliance check at the location. During the check, the on-duty clerk sold a vape product to a 16-year-old youth. At no time during the visit did the employee ask the youth for identification, date of birth or for his age. This was the third violation at the location for sale of tobacco products to a minor. **The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the tobacco certificate.**
