**ORDER ON SHOW CAUSE HEARING**

Comes now the Hearing Judge for the Indiana Alcohol and Tobacco Commission (“Commission”) and submits to the Commission, pursuant to 905 IAC 1-37-9, this Order on Show Cause Hearing:


1. Permittee applied for and was issued employee permit number BR2074092 (“Permit”) pursuant to IC 7.1-3-18-9 on July 13, 2025.
2. Permittee was issued administrative violations by Indiana State Excise Police for violations occurring on June 16, 2025 and June 21, 2025.
3. Commission prosecutor sent notice of violation and settlement offer on July 17, 2025.
4. Permittee was advised of a settlement conference date of August 11, 2025.
5. Permittee attended the settlement conference telephonically and discussed the pending matter with the ATC prosecutor.
6. The last contact Permittee had with ATC prosecutor was August 14, 2025.
7. After communication between the ATC prosecutor and the Permittee ceased, this matter was set for a pre-hearing conference before a hearing judge on December 3, 2025.
8. Permittee did not appear for the pre-hearing conference on December 3, 2025.

9. Following Permittee's failure to appear, Permit was scheduled for a show cause hearing on December 17, 2025 for the Permittee to show cause why Permittee was not required to appear for the pre-hearing conference.
10. Permittee failed to appear for the show cause hearing on December 17, 2025.
11. The Commission has jurisdiction over this matter pursuant to Indiana Code 7.1-1-2-2 and Indiana Code 7.1-2-3-9.
12. If a permittee failed to attend or participate in a prehearing conference, hearing, or other stage of the proceedings, the hearing judge may issue an order to show cause and set the matter for hearing. 905 IAC 1-37-9.
13. At the hearing on the order to show cause, evidence will be taken on the issue of the permittee's failure to appear, and sanctions may be imposed including a fine, suspension, or revocation. 905 IAC 1-37-9.

**Proposed Order**

Hearing Judge now submits to the full Commission the following recommended order for adoption:


**IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED** that permit shall be REVOKED following Permittee's failure to appear at scheduled pre-hearing conference and show cause hearing.




