### ORDINANCE 838

### ORDINANCE DESIGNATING AN OUTDOOR REFRESHMENT AREA

WHEREAS, the Indiana General Assembly Senate Bill 20, which went into effect July 1, 2023, allows a city or town to designate an outdoor location as a refreshment area; and

WHEREAS, the Town Council ("Council") of the Town of Yorktown, Indiana has determined that the Town of Yorktown would benefit from designating an outdoor refreshment area; and

THEREFORE, BE IT ORDAINED by the Council that the Civic Green Park and the Downtown District are collectively a designated outdoor refreshment area for the following days and times:

Monday	8:00 AM - 12:00 AM
Tuesday	8:00 AM - 12:00 AM
Wednesday	8:00 AM - 12:00 AM
Thursday	8:00 AM - 12:00 AM
Friday	8:00 AM - 12:00 AM
Saturday	8:00 AM - 12:00 AM
Sunday	12:00 PM - 12:00 AM

**BE IT FURTHER RESOLVED**, the boundaries for the refreshment area will be designated by the following streets in Yorktown, Indiana:

- 1. to the north, the north side of Canal Street including the sidewalk;
- 2. to the south, the south side of W. Smith Street including the sidewalk and encompassing the quarter block at 9101 W. Smith Street and the parking lots at 9135 W. Smith Street;
- 3. to the east, the east side of Broadway Street including the sidewalk and American Legion property located at 2110 N. Broadway; and
- 4. to the west, the west side of Plum Street including the sidewalk

BE IT FURTHER RESOLVED, the designated outdoor refreshment area is consistent with the Town of Yorktown's zoning ordinance; and

- **BE IT FURTHER RESOLVED**, the Town of Yorktown will be displaying ACM signs to visibly designate the outdoor refreshment area, six (6) of which will be displayed at the extreme boundaries of the refreshment area at the following locations:
  - 1. at the intersection of Canal Street and S. Plum Street,
  - 2. 287' south of the above, at the intersection of S. Plum Street and W. Smith Street,

- 3. 1275' west of the above, at the intersection of Broadway Street and W. Smith Street.
- 4. 287' north of the above, at the intersection of Canal Street S. Plum Street,
- 5. at the north pavilion at the Civic Green at 9312 W. Smith Street,
- 6. 202' south of the above, at the south pavilion at the the Civic Green;

BE IT FURTHER RESOLVED, the Town of Yorktown will be displaying ACM signs at each of the Designated Permittees on the premises marked on the map below; and

BE IT FURTHER RESOLVED, that participating Designated Permittees during the above dates and times must abide by all Indiana liquor laws and licenses; and

BE IT FURTHER RESOLVED, that the participating Designated Permittees within the designated outdoor refreshment area are identified on the map attached; and

BE IT FURTHER RESOLVED, that all contradicting established Park rules are void during the planned events; and

NOW THEREFORE BE IT RESOLVED, that the Town Manager and their assigned staff and partners are hereby authorized to plan events in a manner consistent with Indiana law as set forth above.



# Dora Boundaries and Designated Permittee Locations




