Updated 11/11/22 NPUSC policy and practice for Policy 2260 Non-Discrimination and Facility Access.

NPUSC Families and Staff,

This communication is an updated statement (11/11/22), after additional consideration, around NPUSC policy and practice for NPUSC Policy 2260 Non-Discrimination and Facility Access as it relates to gender identity.

Pertinent facts and final determinations are included in this communication, including the original announcement shared at the August 8th board meeting:

Why has NPUSC changed its practice related to restroom access?

NPUSC has had a policy in place for many years addressing "federally protected" classes to ensure equal access to programming and facilities. That policy was recently updated in 2021. Federal law defines protected classes such as race, national origin, color, and sex, also defined as gender status, gender identity, and sexual orientation.

NPUSC previously allowed transgender students to use neutral locations such as a staff bathroom. However, after review of federal court cases throughout the United States including the Mid-West, it was clear federal courts and federal law were consistently protecting transgender students' rights to access the restroom of their identifying gender if requested.

In conclusion, since NPUSC policy already protected these students, NPUSC changed its interpretation of the policy to be compliant with federal law and related federal court case precedent, and to be more supportive of the transgender student population within NPUSC schools

What exactly is the NPUSC practice now and why?

Consistent with federal guidance and court case legal precedent, students with official transgender status are given the option to use a neutral restroom option such as nurses station or staff bathroom, or to use the restroom of the identifying gender. Legal precedent has clearly established transgender students must have this option. Multiple school systems in the United States, the Mid-West, and Indiana have lost lawsuits when challenging this precedent, which have included instances of settlements with taxpayer dollars being paid out for discrimination.

Also, recent studies show that transgender students are 4 times more likely to commit suicide than other teens (Johns, 2020). This research was of great concern to NPUSC leadership, which has also led to a change in practice to be more supportive of our transgender student population

What is a Gender Support Plan? Is it accurate that our schools are hiding transgender information from parents?

To ensure safety of all students and support for transgender students, NPUSC has created a Gender Support Plan, which is an internal document used with transgender students only *-An updated example is attached below. NPUSC Social Workers and Counselors utilize this document to ensure students of transgender status have access to the legal precedent with restroom access, and other necessary aspects are addressed in an individualized plan such as pronouns to be used in class.

"Let's Talk Session" NPUSC Board Policy 2260 – Nondiscrimination and Access to Equal Educational Opportunity

October 24, 2022

A "Let's Talk Session" was held on Monday, October 24, 2022, with Mr. Phil King, Mr. Dale Groves, Mr. Jason DeMeyer, Mr. Al Williamson and Mrs. Jill Smith present. Dr. Paul White was also present.

- Mr. King opened the "Let's Talk Session" stating the topic of this session is to specifically discuss the NPUSC Board Policy 2260 – Nondiscrimination and Access to Equal Education Opportunity. Mr. King read the Board policy on the rules of the "Let's Talk Session".
- Erica Clark LaPorte Mother of 4 boys in the NP District, explained her shock when she learned that children, who need parental permission and signature for everything under the sun, can all of a sudden choose a life changing identity that can affect their mental health unbeknownst to parents and kids can do this at any grade in the District. She was told that the reason for not telling parents is to keep kids safe in case parents are not accepting of it. How many times do kids make decisions that parents are not happy about? Lots. In fact, tell me how having someone lie to their parents about a huge life decision is good for their mental state? Yet, your also worried about a suicide rate with the same person. The last time the government tried to keep us safe, mental health issues sky rocketed. Remember, kids came to school identifying as cats and dogs? To know that this includes elementary students blows my mind. How are you helping young innocent children by telling them or giving them the option that they aren't born to be who they want to be making them feel wrong in their own body. They cannot possibly make this huge decision at their young age in fact those confused middle schoolers cannot either. As for any adults confusing these kids and putting these ideas in their heads it is clearly not about raising healthy children to you. Children need to be encouraged that they are beautiful just as they were born. It is sickening to know that society is making this so common and popular yet common sense knows that it is not healthy for their well-being and their mental state. So, why are we encouraging it? Regarding the restroom and locker room situation, there is a huge percentage of students that do not feel comfortable with someone of the opposite sex using the restroom at the same time as they are in the same room and rightfully so. Can a child be taught nonacademic instruction without my parental consent? No. Indiana Code Title 20, Article 30, Chapter 5, Section 17b explicitly prohibits that. All this is an attempt to comply with the Federal Government's guidance as a result of Title 9 executive order. The original amendment of 1972 states that no person shall be excluded in participation, be denied the benefits of, be subjected to discriminating under any educational program on the basis of sex. Sex meaning male or female. Non-compliance as a result of Federal Assistance. History of how we got here, May13th 2016, Obama administration issued a letter using significant guidance for schools in applying Title 9 to students who are targeted for their gender identity including transgender status. And there is also a girl on the high school football team who just scored 2 touchdowns. Ill bet many of you are against that also. The private voucher schools can discriminate. Public schools cannot. Private and voucher schools can keep kids for the head count, if there is problems with them they send them back to the public school and keep the money for the student. If I am not mistaken, the special ed students scores factor into the standardized tests and reflect the states grading of the school. Should we discriminate against them too?
- Joe Emerick Rolling Prairie First off, I would like to say thanks to Mr. King and Dr. White for answering my questions straight forward on previous email correspondences back and forth. I may have disagreed with what they sent me but I do appreciate the candid and straightforward response. I don't agree with a lot of what is going on right now. I am still trying to navigate it. I'm a little bit shocked really. Partly I blame myself for not being involved enough and keeping an eye on what is going on. I think a lot of people feel that way. But, I also, from all the research I am doing, it doesn't seem like this fight is really over as you guys imply but this is just legally required we have to do all this. There is a lot of fight still going on out there. Our own Attorney General is doing a lot of that fighting along with other state Attorneys General. The more I look into this I see this not clear cut. One of the most disturbing things to me, as other people have already brought up, this gender support plan concept and the fact that you

guys feel like it is ok not to tell parents what's going on. You guys say yourself that people with gender dysphoria or confusion in this area have a higher rate of suicide. I don't support that and I think on a state mandated level where our children are failing, IREADs and all this, we should be putting our money and focus into the schools for their learning not the sexual orientation as kindergarteners. Secondly, I am a mother of 4 very athletic children, you congratulated New Prairie Volleyball, congratulations, my daughter was a volleyball player, the runner, congratulations to her, fantastic, what about the mentality of you allowing male athletes to compete with the females and their mentality when they are being embattered up because a male is going to take their semi-state recognition because they feel they are not strong enough to battle a male. So, I don't agree with this on the level of athletic civility for our students whether it's the young boys that want to compete in dance or the young men that want to play, whatever I don't know, but you get my point. I think that it's wrong, we all think that our children should have a fair playing ground education wise and sports wise and this is completely wrong.
- Kimberly Spencer New Carlisle Mother of a 16-year-old daughter, I'm speaking on behalf of her and other kids like her rights. I do not agree with transgender kids using any bathroom they choose to. If you want a transgender bathroom, that's fine, but my daughter's rights should not be violated because some other child, a boy, wants to use her bathroom. Who is looking out for her rights in this. We're all worried about transgender families suing you, what about all of us getting together and suing you for non-transgender rights. Have you thought about that? When I was younger, I went into a boy's bathroom for a dare, I got in trouble for that. Nobody was in there. But I got yelled at by my parents. Where are those morals and values now? They have gone by the wayside. Next, we got kids that are acting like cats are we going to put litter boxes in the hallway for them? Where do these rights end? I don't understand. Where are our rights as parents who are non-transgender kids where are their rights not going to be violated?
- Lori McCarty Mill Creek Has 4 grandchildren in this school system. Thank God the 18year-old is graduating this year so we don't have to deal with that anymore. The 16-year-old

- can pretty much make her own decisions on how she feels about anybody. We never taught our grandchildren, our kids in my family to disrespect elders and disrespect anybody else that they were in school with, not to be prejudiced, not to be racist. But now your taking 99% of these kids and your being prejudiced because there is less than 1% over here thats complaining that things aren't fair. So, I want to know what your going to do for my 6 and my 8-year-old grandchildren that are in this school if they don't feel comfortable.
- Roxann Romero Rolling Prairie I will not take the full 3 minutes a lot of people have said what I feel. I want you to know first of all that I love all children, I love them all equally and we have to protect them all. By taking away parental rights we are not doing that. I appreciate when you said, Dr. White, that if you thought a child would commit suicide you would let the parents know but we don't know that ahead of time. Children commit suicide without giving signs. And if it is where they are 4 times more likely parents need to know. The parents need to know. I think these policies whether they are from the federal government or who they are they are just going to encourage parents to take their children out of the federal school system and then this will collapse like a house of cards and there will be no funding for anything. We have to think of all of the children not just some of the children and I want all the children protected. What happened to the women libers in this country? All of a sudden women's rights don't matter? Since when is it fair for a man to compete against a woman in a woman's sport? Take their scholarships, take their awards, it's not fair. So, the one thing I want to say to everyone, is November 8th we all need to go out and vote. That is where our voice is going to count.
- Erin Jenkins LaPorte, As a social worker my job is to create a safe and non-judgmental environment for my clients to thrive. Often this means meeting them where they are and offering support. Our students and children in this community are figuring out who they are and having a loving and supportive environment is key so children can thrive in other aspects of their lives. The 2022 national survey of LGBTQ youth reported that 45% of LGBTQ youth seriously considered attempting suicide in the past year and nearly 1 in 5 transgender youth attempted suicide. The survey reports that LGBTQ youth who found their school to be LGBTQ affirming reported lower rates of attempting suicide. Gender affirming language is suicide prevention. As children are growing and becoming who they are we want to give them the opportunity to thrive and feel full of life, not hopeless. This is all new for some of us and can be scary and confusing at times but we owe our children the support and openness to learn and adapt. I encourage anyone who is struggling with these changes to visit trevorsproject.org and the LGBTQ Center of South Bend website and social media to learn more. We will not all agree on everything but I encourage as we move forward and changes are happening to be respectful and kind when disagreements arise. The children in our community are watching. Thank you to the School Board for creating a safe and supportive environment. Thank you.
- Donna Johnson LaPorte I will tell you one thing, this is an issue that is tearing apart our community. Teachers, schools, parents, we all love our children. You love our children. Why are we tearing apart our communities over this issue? If I in the past, I'm 78 years old, if I came up here and said "I decided that I a man and not a woman". Well every chromosome in my body is XX I'm a woman no matter what part you take off and what part your gonna add. And I came in here out of love for children. My heart is broken over these children. And you talk about suicides with these people who are, in the past we would have said they need some mental health. Schools can't do everything, you're a public school you are limited. And these issues need to be addressed, and I, yes, and I know people too and they're disturbed. And you know what, not just the people who have these issues we are talking about, the 1%, but the 99% too their suicides are up, their drug use is up, their depression is up and guess what, I thought schools were for educating and academic standards, for decades the academic standards have been declining and COVID didn't help and it is statistical that your shaking your head so the standards for academic excellence is declining and you can look over and over again and New York, 62% of the 12th graders are not proficient in English and more so

not proficient in Math. So that was my add on. When I came here, what you have on your sheet here, I could grow taller too, see if I were a man I would be taller, I would be stronger. Um, all these title things, all these transgender things, Title 9, that Title 9 was not about transgenderism, it was about sex, ok, so, I have 3 things that I took from Todd Rokita's information pertaining to these laws and by laws, Indiana has codes and laws pertaining to the education. The education and these programs is not included in the codes. There is a 20 state preliminary injunction granted regarding the January 20, 21, the executive order by President OBiden concerning the sex discrimination based on gender identity- that is not correct. Ok and Todd Rokita addresses it. I have copies for you. They're excerpts, they're just pieces I took out from the whole thing, they're kind of lengthy, I'm not an attorney, I don't know these things, but I can read, still, in my old age. Uh, so here it is, so July 15th, 2022 was a petition there, the other thing I have here is August 8th, 2022, the intervener, State of Indiana response to the appellate petition to transfer, you can't change a recorded sex on a birth certificate ok. And then September 12th, 2022, Title X notice proposed rule making docket this redefining term of biological sex to mean gender identity, it doesn't.

- Michelle Wilson South Bend In Dr. White's recent email, 1% of students identify of transgender and are 4 times more likely to commit suicide. Why not use those resources on restroom renovations to provide mental health services that 100% of our students could benefit from. Maybe incorporate school wide anti-bullying presentations, anti-vaping, both are epidemics amongst our youth. I get sexual orientation might be something a high schooler is questioning thanks to social media and the dopamine addiction. But what message are we instilling in our elementary students by renovating restrooms. Isn't the school corporation in fact creating and adding to the confusion of sexuality. I am tired of this school corporation force feeding a liberal agenda that I as a unapologetically Christ centered parent have a to undo every evening. Stop making an issue of pronouns. You are a he or a she not a they or a cat. You are willing to make 1% decisions to avoid a law suit, when you should be worried about a law suit from the 99. Everybody has their own idea of what's right and wrong in this room, you guys have to choose that. Bottom line is God decides what's right and wrong in the Bible. This is a matter of right and wrong. You guys have the opportunity to do what's right in your own eyes or what's right in God's eyes. Please do what's right in God's eyes.
- Rufino Gayton New Carlisle I was kinda surprised when I saw the email come out from you Dr. White explaining all this stuff. I had heard some rumors. I blame myself a little bit for not being more involved. That will be changing from this point forward. But, I did see that you cited multiple legal precedents, and legal hearings or case studies that are going on right now. I don't know if you guys read those, I did. I read every one of them word for word. Alright, now, I will tell you that Title 9 did expand to go beyond just sex. It did incorporate the gender identity and orientation. That's great, lets protect all our children. They're children at the end of the day, we should protect them. But I will also say, that most of the case studies that you listed here are dealing with employment situations. Last time I checked there wasn't a student here that worked for you guys. They're all students, they're not employees, this was employment stuff. Um, the Whitaker vs Kenosha, I believe in that one, it actually referenced gender dysphoria as a mental disease. It's a mental illness that needs to be taken care of, isn't something that just is gonna disappear. The rest of the cases, the 3 that you guys cited for Indiana, Evansville, the Vigo (?), the Metro School District of Martinsville, all based their decision off of Whitaker, well, all 4 of these cases are injunctions, injunctions are just a temporary pause in a particular policy or situation. There have been no injunctions on file against New Prairie District. You didn't have to change the policy that you currently put in place. I will leave, I'm gonna leave this, and I don't know if you guys are aware, my daughter was involved with a situation with a transgender student last year. She was in the restroom; this transgender student came into the restroom, she quietly left because she was uncomfortable. She was in there with about 6 other students. Well that transgender student recognized my daughter and he felt it necessary to threaten my daughter via your iPad communication in your gmail. I called the school and guess what happened? What just happened? Nothing. Ok. I didn't get a call back, the kid didn't get disciplined, and here we are, I had my daughter in the bathroom, 16 years old with a fricken hormonal boy in 15 years old. Completely unacceptable and this is when the policy was you can use the staff restroom or use the nurse's restroom that you guys had last year. My daughter still was violated. I'll leave you with that.
- William Allison Walkerton And my son goes to Prairie View, and we've had to have multiple talks with him over all this crap that's goin on. Cause he's freakin out of, ok what do I do when a girl walks in my bathroom? I tell him either walk back out wait she to be done but don't pick on her. But the main issue is what's goin on if you google it all these other states got these bathrooms that all these transgenders or whatever you want to call em, their gettin picked on, they're bein raped and who knows what else is goin on in these restrooms. Where we gonna draw the line on this stuff for this 1%. Even with this litter box stuff? If it comes here, where you guys gonna draw the line on that? God made Adam and Eve, not Steve and whatever.

It's, this is gettin ridiculous and out of hand. Somebody's gotta draw the line somewhere bout this.

- Jen Miller Rigg Street I just came to say I feel like a lot of people have already said what I wanted to share but I thought that I just wanted to say that after reading the email I know that your hands are tied on some things it seems as if. After hearing some comments maybe not as much as what I thought. I think that the most important thing for us is to remember to love these kids and to have empathy for them. And that more than anything else they are broken and confused and because of that we need to love them, and not just love them, we need to love them well. With that said, um, we are seeing a very small percentage, Paul I think you said less than 1% we keep hearing over and over again. And so is there a way that we can take each student in a one by, one by case situation instead of lumping them all together because what's happening is we have a sixth grade girl and a freshman in high school and my freshman came home and said "mom, they asked me my pronouns and I didn't know to answer them" Hmmm, so we're sitting at dinner, and I am thankful for this conversation because then we can educate her right, so we are sitting at dinner together and we can educate about this confusion, we are also Christ followers in our family and we believe that God made everyone just as a masterpiece right. So, they're beautiful just the way they are. And so, with that said, the bathroom situation, is there a way, we see in public restrooms often that there's a male/female restroom. Is there a way that we can promote that? In several places of the high school. Instead of grouping them all together, fixing the stalls, I have girls and they have private situations that they need to deal with. And I think that we can all as women, appreciate that. We want privacy and its uncomfortable for a man to come into our restroom especially for dealing with those private situations. I think that it's important that, and somebody else said this too but, we don' allow our kids to drive until their sixteen, we don't allow them to vote until their 18, but in elementary school and in middle school we are asking them their identity. Who they are? I think that we can all attest that, man we didn't know until we're like 25 years old because thats when the brain is developed. That, man, we didn't know who we were until then. And sometimes, I'm not going to say my age, but sometimes I still question, right, not my identity necessarily but what am I here for, what's my purpose, so we want to ask middle schoolers and high schoolers that question? And make life altering changes? This is ridiculous, so, last thing, can we just stop. I can respect peoples, um, opinions, and I can respect them and love them for if they are trans, I think it's a small percentage as we know, but with that said, can we stop pushing it on everybody else? There's about 2 or 3 teachers that are asking pronouns at the beginning of the year. I feel like there has been some incidents where my daughter has known a transgender girl and honestly, we tell our kids, hey, we are gonna love everybody right. That's just how we teach them. With that said, my daughter knows the girl is a girl and she called her the girl's name because that is how she has known her for the last 8 years and the teacher reprimanded her, She is not that anymore, she is this name. Now come on.
- Mr. King stated that they will look into that. As far as the gender support plan, that does not go
 out to every student. So, if your daughters are being asked their pronoun, we are gonna look
 into that because that should not be happening. If you don't mind, we will be in contact with
 you as we want that information please.
- Austin Kosinski New Carlisle I graduated in 2016 I'm also from the elementary here and the high school. Went away a few years, came back, settled down, had a family and started getting involved and what a mess we have today. Vaping, litter boxes, people of the opposite gender in bathrooms. Things are way worse than we probably image. The social worker mentioned the Trevor's Project, not only will the school keep private the identity of transgender students so we don't even know if 1% is accurate. But, the Trevor Project and other programs like that will also send hormones secretly to your kids. So, you should look into that. For

anybody who has kids who are going through crisis of the transgender variety you should have them visit a board called (?) to hear the horror stories of people who made the mistake of believing the ideology that is gender theory. I just had a daughter, I love this town, I want to be here the rest of my life but if things don't turn around I just got to thank you, you lit a fire under my butt, I'm gonna do everything I can to make sure I don't have to have my daughter come here. I want to thank you for all of your efforts, I know that you guys are working hard to find a solution, but I don't think this is the one, not for the town and I wish you the best luck come voting day.

- Tim Hodum LaPorte I have a daughter that has had issues in this school pertaining to this and I don't know about the 1% but I can see the 1% here and it seems like the 99% is a little bit upset. And, there is something that we have to do better than this. How are you folks gonna guarantee our child's safety in those bathrooms. Are you gonna have somebody, I mean do you have any plans for that? Do you have, you just gonna make a little cubicle and then somebody jumps the cubicle, and I mean what's the plan? Do you have a plan to keep them safe? Can you say yes or no or anything? Can we talk? I mean, because some kind of security needs to be in those bathrooms the entire school day in order to protect, you know, equal opportunity right, equal right? So, protect the 1% and the 99% at the same time. And, my daughter's already had implications I mean I know we identify with what we're not, because, my goodness, what we're not just isn't acceptable. I mean when I walk to school I seen a sign that said "No pets allowed". And, I'm the only dog in my family, so, if my daughter identifies as being, ya know, a legal driver, she's only 13 years old, I don't want her driving my car, so, folks we gotta do something. I just want to know if anybody has a plan. A legitimate plan to keep our kids safe. And I'm not talking about just my kid, I'm talking about the 1 and the 99. Who's gonna regulate that bathroom? We can all get along ya know and um, I just hope and pray that you guys can, that there can be more communication between the parents and you guys. - Donald Comstock Rolling Prairie I just have a concern that my 2 girls go there and if their hearing other children saying they're lesbian or they're a different sex. I don't think you guys are concerned with what my children's feelings are because my girl will not go in a bathroom if there is a boy in there because we teach them a Christian belief that is right or wrong, male, female. Ok now I hear people saying there are 99 and 1. Let's not forget Jesus left 99 for the 1. So that is what I teach my children. So, if I heard you say earlier that there's nothing to do with religion in school, but my kids are being subjected and somebody said they're not sure how many there are of the 1%, still my children are being subjected to that and it doesn't feel like your concerned with them. I mean I don't understand the bathroom thing, I don't get it I mean if there is no religion supposed to be in school, I don't think it's fair that my children should have to be subjected to that. And if that is the case then I think my daughters with their biblical beliefs should be able to bring their bible and scripture and talk to the 1% and maybe turn them to the 99. But you're not letting them do that right? Can my daughter come to school with scriptures and if kid comes up and says she's lesbian, which is fine, I teach my kids love everybody, but is it fair for that or is it alright for my child to bring scripture and read it to them? - Heather Oake LaPorte My husband and I purposely moved from Koontz Lake from 11 years to LaPorte and we chose New Prairie School District to build our house. We did that on purpose. My husband went to New Prairie, we thought it was a great choice between the 2 options that we had. So, when I was a kid, I had a older brother and he was 7 years older than me, he had his friends over all the time, they played basketball with their shirts off, I did the same. I used to cry saying that I wanted to be a boy to my mom. She remembers that. I am very thankful my mom did not take me and get puberty blockers and cut off my breasts. My best friend in high school, this shows how immature we are, I did a lot of stupid, stupid things in middle school and in high school as well, and my best friend became anorexic we were cheerleaders in high school, we slowly noticed it she went from 150 lbs down to in college 73 lbs. There were 3 of us, me, my best friend and another girl, we were like the 3 amigos. My other friend just distanced herself, had nothing to do with her. I stayed friends with her in college. I could have gone along with her mental illness. She would be next to me and she thought she was fat. I could have went along with that but I did not. I prayed for her, I told her parents, her mom knew, her boyfriend. We all knew there was a problem. Her parents had to go down to the college, drag her out and put her in a facility and then even work with her at home to get her. Guess what, now she is a teacher in Fishers, IN. She is a very good art

teacher. And um, so there are mental illnesses and we can't say that just because you feel something we can't go along with that when its not right. We could have let her kill herself and say well she feels fat, it makes her happy to not eat, but just go along with this. But there is a right and there is a wrong. Eventually we are going to have to stand for right. Is there, are we going to go along with minor attractive persons are we going to go along with that soon? Minor attractive persons, it's a thing! Are we going to start doing that? Are we gonna throw away our morals for our federal dollars? Are you gonna care about our dollars or are you gonna take the federal money? Because, there is a right and wrong and we are all gonna have to account for it and how we make our decisions. - Aaron Dingman Rolling Prairie I just want to say thank you to all the Patriots coming out tonight in supporting our kids. Its all about the kids. I have 2 boys in school, 6th grade and a sophomore. They have not gone to the bathroom at school in probably about a year and a half. They run home and it's the first thing they do. That cant be good medically because they are afraid to use the bathroom at school. What's being done about that? And also, a child's brain is not fully developed until about 25 years old. Anybody who supports this and the gender dysphoria is child abuse.
- Mr. King stated that is it as far as public comment goes. We thank you for showing up tonight and being considerate of both sides. We appreciate that. Conversations are happening all the time and if you have any other questions or what not, I know we took notes, there are some things that are kind of alarming.
