FEDERAL & STATE LAW



- **TITLE IX (FEDERAL) PROTECTS LESBIAN, GAY, BISEXUAL, & TRANSGENDER STUDENTS FROM GENDER DISCRIMINATION**
- **INDIANA CODE PROHIBITS BULLYING ON THE BASIS OF ACTUAL OR PERCEIVED SEXUAL ORIENTATION, GENDER-RELATED IDENTITY OR EXPRESSION, AND/OR ASSOCIATION WITH A PERSON OR GROUP WITH ONE OF THE AFOREMENTIONED ACTUAL OR PERCEIVED CHARACTERISTICS**

GENDER SUPPORT PLAN



ADDRESSES THE EXPRESSED INTENTIONS OF A TRANSGENDER OR GENDER-EXPANSIVE STUDENT, INCLUDING...

- **NAME**
- **GENDER IDENTITY**
- **DEGREE OF DISCLOSURE TO TEACHERS & OTHER STAFF MEMBERS**
- **DISCLOSURE IN STUDENT RECORDS**
- **ACCESS TO RESTROOMS**
- **ACCESS TO LOCKER ROOMS & OTHER GENDER-SEGREGATED FACILITIES**

STUDENT MAY STAY IN OVERNIGHT ACCOMMODATIONS WITH OTHER STUDENTS OF THEIR GENDER IDENTITY

OVERNIGHT ACCOMMODATIONS

- **STUDENT MAY SELECT FRIENDS WHO ARE COMFORTABLE ROOMING TOGETHER**
- **PARENTS PROVIDE APPROVAL FOR THEIR STUDENTS TO ROOM TOGETHER**
- **IF SINGLE ROOM ACCOMMODATION IS SELECTED, STUDENT PAYS THE SAME AS OTHERS WHO ARE SHARING A ROOM.**
- **PARENT CHAPERONES MAY BE NOTIFIED THERE IS A TRANSGENDER STUDENT ON THE TRIP WHO MAY USE APPROPRIATE RESTROOM BUT NOT WHO THE STUDENT IS UNLESS OUTLINED IN GENDER SUPPORT PLAN**
