A speed title ensures that the title is processed in a substantially shorter period of time than the normal processing period. Seven percent (7%) sales tax, unless proof of sales tax paid or exemption is provided. \Box Registration Fees: Registration fees and taxes vary based on location, vehicle type, and registered weight.
