

## Directions to the Board of Veterinary Medicine Office

**From the Northwest:** From Interstate 65 to Indianapolis: Take the 38th Street East exit. Drive 5 miles east on 38th street to the Indiana State Fairgrounds, which will be on your left (north). Turn left at Gate 1 and continue through the fairgrounds to the northwest corner. See map below for directions around the fairgrounds.

**From the West:** Take Interstate 465 to the 38th Street East exit. Drive 5 miles east on 38th street to the Indiana State Fair grounds, which will be on your left (north). Turn left at Gate 1 and continue through the fairgrounds to the northwest corner. See map below for directions around the fairgrounds.

**From the Northeast:** From Interstate 69 to Indianapolis: Take Binford Boulevard exit and go 5.7 miles. Binford Boulevard becomes N. Fall Creek Parkway. Continue on for 0.5 miles, then turn right into the Indiana State Fairgrounds at Gate 6. Continue straight until the round-about, then follow the dots on the map below.

**From the South:** Take Interstate 65 to Indianapolis: Once downtown, take Interstate 70 E via exit toward Columbus, OH. Take exit 85B toward N. Keystone Avenue. (Keystone Way becomes Keystone Avenue.) Continue 1.5 miles north to 38th Street. Turn left. The Indiana State Fairgrounds will be located on your right. See map below for directions around the fairgrounds.

**From the East:** Take Interstate 70 toward downtown Indianapolis: Take exit 85B toward N. Keystone Avenue. (Keystone Way becomes Keystone Avenue.) Continue 1.5 miles north to 38th Street. Turn left. The Indiana State Fairgrounds will be located on your right. See map below for directions around the fairgrounds.

**NOTE: The Office Entrance and Parking**  
are located on the north side of Discovery Hall.
