STATUTORY RESPONSIBILITIES



INDIANA COMMISSION *for*
HIGHER EDUCATION

IC 21-14-2-12.5

- (a) This section applies to tuition and mandatory fees that a board of trustees of a state educational institution votes to increase under section 7 of this chapter.
- (b) Not later than thirty (30) days after the enactment of a state budget, the Commission shall recommend nonbinding tuition and mandatory fee increase targets for each state educational institution.
- (c) The state educational institution shall submit a report to the state budget committee concerning the financial and budgetary factors considered by the board of trustees in determining the amount of the increase.
- (d) The state budget committee shall review the targets recommended under subsection (b) and reports received under subsection (c) and may request that a state educational institution appear at a public meeting of the state budget committee concerning the report.


ENROLLMENT & COMPLETION LANDSCAPE


- ▶ Last fall, Indiana recorded 2.2% enrollment increase across its public institutions and 3.3% enrollment increase at its private non-profit institutions
- ▶ Indiana now 9th in nation for completion rates
- ▶ Considerable factors in our state's ability to increase enrollments and completion rates include our need-based financial aid programs and overall affordability

TUITION PRICING LANDSCAPE

- At Indiana's public four-year colleges, in-state tuition and mandatory fee rates fell by an average of **-1.2% annually** over the last decade (constant dollars); **the 8th largest decline in the nation**




AFFORDABILITY LANDSCAPE: STRADA STATE OPPORTUNITY INDEX

STICKER PRICE LANDSCAPE

Heart and Mind Strategies Research Findings

About 1 in 4 Hoosiers surveyed who report cost as a barrier do not believe reported tuition numbers.

Weighted: HS Students (n=817); YA Students (n=497); Adult Learners (n=301); Parents of HS (n=798); Parents and Family of YA (n=298)



Q810_A. How believable is this information to you? "As of 2021-22, the average annual cost of in-state tuition to a 4-year public college or university in Indiana was \$9,780. During the same year, it was \$4,637 at a public 2-year institution. This is the cost that someone who does not receive any financial aid would pay."

Actual costs viewed with skepticism; all tend to over inflate the cost of annual in-state tuition.






NET PRICE LANDSCAPE

- ▶ At four-year publics (nationally)
 - ▶ Net price for families has declined since 2016-17 and hovered at \$17K last few years
- ▶ At two-year publics (nationally)
 - ▶ Net price for families has declined since 2020-21 and hovered at \$9K last few years

Bottom line: sticker/published prices contribute to misperceptions of actual cost



- ▶ Higher Education Price Index (HEPI)
- ▶ Higher Education Cost Adjustment (HECA)
- ▶ Consumer Price Index – Urban (CPI-U)
- ▶ Consumer Price Index - Urban (Less Food and Energy) (CPI Core)
- ▶ Consumer Price Index - Midwest Region (CPI-MW)
- ▶ Consumer Price Index - Education and Communications (CPI-Ed&Com)

 - ▶ \$1B shortfall
- ▶ April revenue forecast below expectations
 - ▶ \$2B shortfall

- ▶ Commission has historically considered each of the following in developing its recommendation:
 - ▶ Improving educational access and attainment
 - ▶ Affordability
 - ▶ National tuition-setting landscape
 - ▶ National and state economic landscape

CHE RECOMMENDATION HISTORY



INDIANA COMMISSION *for*

- ▶ Over last 8 biennia CHE maximum recommendation has ranged from **0% (floor) to 4.70% (ceiling)**
 - ▶ 2023 – up to 3.50% (3-year CAGR for 6 indices)
 - ▶ 2021 – up to 1.45% (3-year CAGR for Midwest CPI)
 - ▶ 2019 – up to 1.65% (3-year CAGR for 6 indices)
 - ▶ 2017 – up to 1.40% (3-year CAGR for 6 indices)
 - ▶ 2015 – up to 1.65% (3-year CAGR for Midwest CPI)
 - ▶ 2013 – up to 2.00% (3-year CAGR for 6 indices)
 - ▶ 2011 – up to 3.50% (varied by institution)
 - ▶ 2009 – up to 4.70% (varied by institution)





- ▶ Governor Braun took office in January with the mindset of being efficient and finding savings in all levels of state government. The revenue forecast shows state must continue this effort with more vigor.
- ▶ The final state budget confirmed the Governor's direction: nearly all state agencies received at least a 5% operating reduction with an additional 5% held in reserve, including higher education institutions.
- ▶ Efficiencies and savings to be found in all levels of state government



- ▶ Out of all state entities, our higher education institutions are in the best financial position to weather these cuts
- ▶ Institutions should address the reductions in the same way as other state entities: refocusing on their core missions and then finding efficiencies in accomplishing those, eliminating redundancies, and identifying ways to streamline the delivery of higher education
- ▶ For these reasons, the Governor Braun requests the Commission recommend institutions hold tuition and mandatory fees flat.


- ▶ The Commissioner fully supports the Governor's recommendation
