




INDIANA'S 5-YEAR ENROLLMENT DECLINE LESS THAN MOST STATES




INDIANA ENROLLMENT TREND BY INSTITUTION TYPE










Historical average tuition changes from 2009 to 2020





INDIANA VS THE NATION: HIGHER EDUCATION APPROPRIATIONS







STATE FINANCIAL AID RECIPIENTS DRIVE INDIANA'S ECONOMY Indiana public college graduates (2008-2015 annual average)



FIVE PERFORMANCE FUNDING METRICS

- Overall degree completion
- On-time degree completion
- At-risk degree completion (PELL/low-income)
- STEM degree completion
- Student persistence incentive





2020 PERFORMANCE FUNDING FORMULA CHANGES

Overall degree completion metric – 75% overall completion rate bonus

- Issue: It is challenging to earn funding under the overall degree completion metric as an institution's overall completion approaches a high percentage.
- Solution: Implement a bonus to be awarded at the 75% resident graduation rate and above.

At-risk degree completion metric – Increase at-risk per-unit values by 25%

- Issue: Equity gaps remain prevalent in higher education, highlighting the difficulty and importance of successfully serving at-risk students.
- Solution: Increase the at-risk per-unit values.

Statewide On-Time Number of Completers





ABOUT THE BUDGET COMPONENTS

- Operating Largest portion of higher education funding; direct state support to institutions
- Student Financial Aid State tuition and fee **Other Higher Education Line Items** – State support for higher education functions, such as support to students attending postsecondary CHE, Medical Education Board, leases, institutions in Indiana Statewide Transfer Website, Budget Agency, **Debt Service/Capital** – State support for etc.
- academic/administrative buildings bonded through student fees
- **Institution Line Items** Specific line items housed within institutions for programs and services outside of the general operations (includes dual credit)

Repair and Rehabilitation – State support for maintenance and upkeep of academic/administrative buildings

BUDGET INPUTS

- Keep performance funding pool flat at 7% Fund existing line items at FY21 in both FY22 and FY23 with 2% new appropriated amount and recommend no new line items funding and 5% reallocation of the base
 - New funding reflects Commission's commitment to partnering with institutions to increase the level of performance funding in Indiana
 - Recognizes institutions' commitment to keeping tuition increases low

- Fund dual credit at \$50 per credit hour
- Fund no new capital projects for this biennium
- Fund R&R at .50% (matching last four biennia levels)







MAINTAINING SUPPORT FOR FINANCIAL AID AND THE COMMISSION

- Fund financial aid funds at the FY21 appropriation level
- Fund the Midwestern Higher Education Compact fund at the FY21 appropriation level
- Fund big four administrative funds at 90% of the FY21 appropriation level (10% cut)
 - CHE administration
 - 21st Century Scholars administration
 - LearnMore Indiana \bigcirc
 - Statewide Transfer & Technology


