# Collegiate Purple Star Awarded to 28 Indiana Postsecondary Institutions

The designation honors institutions that have successfully demonstrated a supportive environment for their military-affiliated students

(INDIANAPOLIS) — The Indiana Commission for Higher Education (Commission) and the Indiana Department of Veterans Affairs (IDVA) inaugurally awarded 28 institutions with the Collegiate Purple Star of Indiana (CPSI). The CPSI recognizes eligible postsecondary institutions that have successfully demonstrated a supportive environment for its U.S. military-affiliated students from application to graduation.

Honorees successfully demonstrated a commitment to excellence by serving military-affiliated students in Indiana through one of three tiers of service. The Commission and IDVA jointly awarded designations based on 37 standards across eight categories: core requirements, marketing and communication strategies, admissions and enrollment, financial support, institutional support systems, student support services, student engagement, and career and community engagement opportunities.



"The Commission is proud to honor these institutions with the state's first-ever Collegiate Purple Star Award," Indiana Commissioner for Higher Education Chris Lowery said. "These institutions set the benchmark for educating military-

affiliated students. As part of the <u>HOPE Agenda</u>, Indiana strives to be a top ten state in postsecondary attainment for veterans and overall economic and social mobility and prosperity. This honor celebrates colleges that have intentionally cultivated a military-supportive environment."

Integrating this program into higher education fosters an environment of respect, gratitude, and support for military personnel and their families."

The CPSI was established with the passage of Senate Enrolled Act 384-2023. The tier designation is valid for three years. However, an institution may apply again in the next cycle in order to reach a higher tier or percentage. Participation in the CSPI is voluntary for all eligible institutions.
