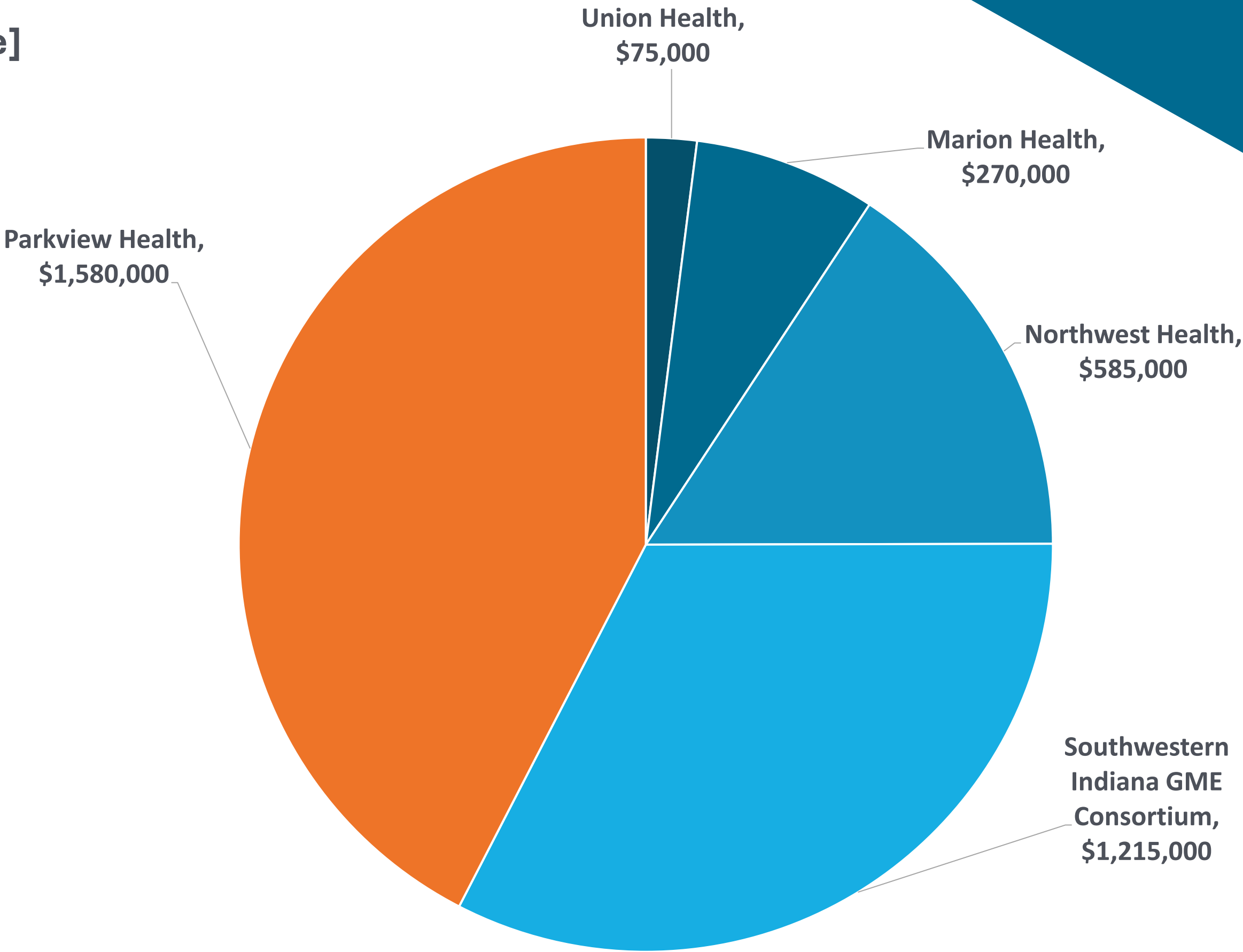

CURRENT BUDGET

- ▶ FY2025 Remaining Funds: **\$11,525**
- ▶ FY2026 Appropriation: **\$7,000,000**
- ▶ Staff & Administrative Expenses: **(\$100,000)**
- ▶ FY2026 Available Funding: **\$6,911,525**
 - ▶ For use between July 1, 2025 – June 30, 2026

GRANT ADMINISTRATION STRATEGY DISCUSSION

- ▶ Funding level will remain flat from the FY25 appropriation.
- ▶ The Graduate Medical Education Board has existed for one decade.
- ▶ There is opportunity for the Board to evaluate and assess current practices, such as the rubric and scoring, so that investments are prioritized where they are most needed.
 - ▶ FY2026 Available Funding: **\$6,911,525**
 - ▶ One (1) Program Development Grant: **(\$500,000)**
 - ▶ One (1) Feasibility Study Grant: **(\$75,000,000)**
 - ▶ FY2026 Available Funding for Residency Expansion: **\$6,336,525**
