- ▶ Outcomes-Based Performance Funding (OBPF)
 - ▶ Tie a portion of state appropriations to higher education institutions based on performance on pre-defined metrics.
 - ▶ Metrics tied to three main branches of HOPE Agenda for **Indiana resident students only** except Graduate Retention.
 - ▶ Enrollment
 - ▶ Completion
 - ▶ Graduate Retention

- ▶ Institutions appropriated funds by the state for the 2025-2027 Biennium:

Type	Description	Funded for 2527 Biennium?
Operating	Funds for "personal services", "services other than personal", "services by contract", "supplies, materials, and parts", "grants, subsidies, refunds, and awards", "in-state travel", "out-of-state travel", and "equipment	Yes, 5% reduction from 2325 Biennium
Operating Prospective	Funds for “operating” subject to IC 21-18-16-7	No
Debt Service	Funds includes payments to universities to be used to pay indebtedness resulting from financing the cost of planning, purchasing, rehabilitation, construction, repair, leasing, lease-purchasing, or otherwise acquiring land, buildings, facilities, and equipment to be used for academic and instructional purpose	Yes
Repair and Rehab	Fund for preventative maintenance, repair, and rehabilitation	Yes, but for FY26 only
Line Items	Funds for Dual Credit reimbursement and other special projects (capital)	Varies, 5% reduction from 2325 Biennium


OBPF AS % OF APPROPRIATION




