## Final Recommendations

### 2025-2026 Academic Program **Under-Threshold Review**

In accordance with [Indiana Code 21-18-9-10.7](#) (HEA 1001—2025), state educational institutions must seek approval from the Indiana Commission for Higher Education (Commission) to continue an under-threshold degree program. If the Commission does not grant approval for a program, the institution must eliminate the program, and any costs associated with it.

An under-threshold degree program is defined as a program having a rolling three-year average of graduates under the corresponding statutory threshold:

- 10 graduates for an associate degree
- 15 graduates for a bachelor's degree
- 7 graduates for a master's degree
- 3 graduates for an educational specialist degree (Ed.S.) or a doctorate

The Commission's inaugural threshold review is comprised of the most recently available completions data: FY 2022, FY 2023, and FY 2024. Beginning in June 2025, prior to the statute's effective date, the Commission provided institutions with an 'Opportunity for Voluntary Early Action.' Six of seven state institutions decided to immediately or by AY 2026-2027 streamline 371 under-threshold degree programs (and some above-threshold programs) through elimination, suspension, or merger or consolidation. Commission approval was neither necessary nor given for voluntary actions executed during this period. However, some programs involved in summer actions and commitments still necessitate Commission approval to continue, such as suspended programs, newly created consolidated degrees, and merger or consolidation commitments.

Since July 1, 2025, the Commission has collaborated with all seven public institutions to effectively implement the review statute for all campuses using co-developed resources and templates: 1) a '[Mutual Consensus List](#)' of under-threshold degree programs for the FY2022-2024 three-year period, 2) Commission-staff guidance from [June 2025](#) and [October 2026](#), and 3) maintaining constant dialogue with institutional Academic Affairs staff to address questions and resolve any issues institution has submitted requests for approval for under-threshold degree programs considered under review. These programs are separated into two categories for the review process: 1) **Action Items**, and 2) **Information Items**.

After further explanation of the review categories and process in the pages to follow, this document provides institution-specific sections including their approval to continue requests by category (action items), the Commission staff recommendation, and information items.

Institutional sections include each degree program's under-threshold three-year average of graduates for the period under analysis.

## Action Items

Action Items fall into one of the following approval request categories:

### Item 1: Improvement Plan (Continuing)

An **Improvement Plan** is a request for continuance with an action plan and monitoring to increase enrollment/conferrals and improve industry alignment/career relevance. This type of request provides an opportunity to explain special circumstances, like accreditation capping cohort size, programs credentialing dual credit high school teachers, or a recent curricular overhaul.

### Item 2: Ramp Up and Stop-Out (Continuing)

A degree considered in **Ramp Up** is a Commission-designed special consideration period for recently approved degrees as they build enrollment and produce graduates.

The duration of the period is a basic formula outlined in the table below as the first fiscal year of program approval, plus the extended time to completion defined by Commission staff for the respective degree type, plus three more fiscal years to reach program maturation (at minimum three years of completions).

If programs were suspended and reinstated following a curricular overhaul before July 1, 2025, an institution could request the approval date be reset with the reinstatement date of resumed admissions. A program in Ramp Up that requested Commission approval to continue will have approval for the duration of its corresponding Ramp Up Period. It is subject to under-threshold review the first fiscal year it exits the period.

#### **Ramp Up Formula**

A degree considered **Stop-Out** is a Commission-designed special consideration for programs that are embedded, stackable credentials that serve as way to obtain a credential of value for

stopped-out students, e.g., an associate within a particular bachelor's and a master's within a particular doctorate.

### **Item 3: Mergers or Consolidations**

A **Merger (Streamlining, Absorbing)** is when one or more adjacent program(s) requests to be absorbed by an adjacent pre-existing program. The pre-existing program will accommodate the absorbing program(s) through concentrations or tracks and may subsequently be renamed.

A **Consolidation (Streamlining, Added/To be added)** is the combination of two or more adjacent programs requesting to form a new degree program. The new degree program can accommodate the consolidated programs through concentrations or tracks.

Merge or Consolidate action items are designated as either Pre-July or Post-July:

*A Post-July Merge or Consolidate approval category is a pending action item request to merge or consolidate adjacent programs to streamline curricular offerings. Institutions must conclude this merger or consolidation designation not later than AY26-27 to launch not later than fall 2027 (AY27-28). Many mergers/consolidations involve above-threshold programs.*

*A Pre-July Merger or Consolidation approval category was a commitment during the Pre-July 1, 2025 'Opportunity for Voluntary Action' to merge or consolidate programs not later than AY25-26. Programs not merged/consolidated by the April 1, 2026 Commission meeting must be suspended or remain suspended.*

### **Item 4: Suspend with Teach-Out and Eliminate with Teach-Out (Streamlining)**

**Suspend with Teach-Out** action items are designated as either Pre-July or Post-July:

*A Post-July Suspend with Teach-Out approval category is a voluntary request to suspend a program and make teach-out arrangements toward eventual elimination. The last cohort admitted to the program will be fall 2026.*

*A Pre-July Suspend with Teach-Out approval category is an executed action and/or a commitment during the Pre-July 1, 2025 'Opportunity for Voluntary Early Action' to proactively suspend a program and make teach-out arrangements before AY26-27. The last cohort was already admitted and has entered Teach-Out toward eventual elimination.*

**Eliminate with Teach-Out** action items are designated as either Pre-July or Post-July:

*A Post-July Eliminate with Teach-Out is a voluntary request to eliminate a program with zero enrollments before or during AY26-27.*

*A Pre-July Eliminate with Teach-Out is a commitment during the Pre-July 1, 2025 'Opportunity for Voluntary Early Action' to eliminate a zero-enrollment program before AY26-27.*

## Information Items

Information Items are voluntary actions executed during the summer 2025 (Pre-July 1, 2025). Three actions are described under the Information Item.

### **Item 1: Eliminated (Streamlined)**

A zero-enrollment program eliminated during the Pre-July 1, 2025 'Opportunity for Voluntary Early Action.' Already eliminated, these programs do not require Commission approval to continue.

### **Item 2: Merged or Consolidated**

A **merger (Streamlined, Absorbed)** or **consolidation (Streamlined, Added)** executed during the Pre-July 1, 2025 'Opportunity for Voluntary Early Action' in which the under-threshold degree program was effectively merged or consolidated away. If merged into an above-threshold program, no corresponding action item is necessary. If merged into an under-threshold program, that program will be seeking approval to continue as a 'Pre-July 1 Commitment to Merge or Consolidate (Effective AY26-27)'. If consolidated, the corresponding newly consolidated degree will be reflected under the institution's 'Ramp Up' action item category.

Instead of commitments, many institutions executed the following actions to degree programs during the 'Opportunity for Voluntary Early Action' (Pre-July 1, 2025). Given the nature of these already executed actions, these programs do not require Commission approval to continue. However, they are important components within the larger under-threshold review exercise and, in many cases, intersect with other categories, such as:

- **Executed consolidations** resulted in newly consolidated degrees now in the 'Ramp Up' action item category. Programs consolidated away do not need approval to continue; they are exclusively information item.
- **Executed mergers** of an under-threshold program into another under-threshold program will necessitate approval to continue. The latter, absorbing degree program remains under-threshold and categorized under 'Pre-July 1 Commitment to Merge or Consolidate (Effective AY26-27)' as an action item.
- **Executed suspensions** of an under-threshold program are categorized under 'Pre-July 1 Commitment to Suspend with Teach-Out (Effective AY25-26)' because they remain under-threshold and require approval to continue their Teach-Out as an action item.
- **Executed eliminations** require no approval; they are exclusively an information item.
